## AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," in public assistance,
- 4 providing for the medical assistance transportation program.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 8 as the Public Welfare Code, is amended by adding a section to
- 9 read:
- 10 <u>Section 443.11. Medical Assistance Transportation Program.--</u>
- 11 (a) The department shall promulgate rules and regulations
- 12 <u>setting eligibility requirements, need verification procedures,</u>
- 13 <u>assistance levels and other requirements necessary to operate</u>
- 14 the medical assistance transportation program in an efficient
- 15 and cost-effective manner.
- 16 (b) The department shall promulgate rules and regulations to

- 1 coordinate the operation and management of the medical
- 2 <u>assistance transportation program through regional or</u>
- 3 metropolitan offices if such regionalization would result in
- 4 <u>efficiencies or cost reduction.</u>
- 5 (c) The department shall make fully available to all MATP
- 6 offices the Client Information System (CIS) or any successor
- 7 system designed to track and record information relating to a
- 8 <u>recipient's assistance and eligibility.</u>
- 9 (d) Transportation service providers shall record and submit
- 10 to the MATP office the name and address of each passenger and
- 11 the time and location of each pick up and drop off.
- 12 <u>(e) The department shall develop a standard attestation form</u>
- 13 to be signed by the recipient and the medical services provider
- 14 attesting that the recipient attended the appointment or meeting
- 15 as directed.
- 16 (f) Recipients receiving mileage reimbursement shall record
- 17 the locations of the trip's starting and ending points, the
- 18 vehicle's starting and ending odometer reading for each trip
- 19 direction, the make, model and license plate number of the
- 20 vehicle and the names and addresses of any passengers in the
- 21 vehicle during the trip.
- 22 (q) MATP offices providing transportation services and
- 23 mileage reimbursement through the medical assistance
- 24 transportation program shall satisfy each of the following:
- 25 (1) Transportation services or mileage reimbursement shall
- 26 be preauthorized by the MATP office.
- 27 <u>(2) Transportation services or mileage reimbursement shall</u>
- 28 be authorized only for transportation to medical assistance
- 29 providers.
- 30 (3) The MATP office shall authorize transportation services

- 1 or mileage reimbursement for the least expensive mode of
- 2 transportation that is appropriate for the recipient's medical
- 3 condition and physical capability.
- 4 (4) The MATP office shall authorize transportation services
- 5 for the closest available medical service provider.
- 6 (5) Mileage reimbursement funds shall not be disbursed to
- 7 the recipient unless the recipient submits documentation
- 8 required under subsection (f) and a completed and signed
- 9 attestation form.
- 10 (6) Transportation services shall not be authorized unless
- 11 the recipient has submitted a completed and signed attestation
- 12 <u>form for all previous trips.</u>
- 13 <u>(7) Mileage reimbursement shall be calculated as equal to</u>
- 14 the lesser of the distance from the individual's residence to
- 15 the closest available medical services provider or fifty miles.
- (h) As used in this section, the following words and phrases
- 17 shall have the following meanings:
- 18 "MATP office" means any governmental body or contractor
- 19 providing services under the medical assistance transportation
- 20 program.
- 21 "Medical assistance transportation program" or "MATP" means
- 22 the program funded in part by the Department of Public Welfare
- 23 that provides nonemergency transportation to medical services
- 24 for medical assistance patients who have no other transportation
- 25 available to them.
- 26 "Transportation services" means contracted services provided
- 27 by MATP offices to transport recipients and approved medically
- 28 necessary escorts to medical appointments, including public
- 29 transportation, demand responsive transport, shared ride, formal
- 30 and informal carpooling arrangements and paratransit.

- 1 Section 2. Any regulations inconsistent with the addition of
- 2 section 443.11 of the act are abrogated.
- 3 Section 3. This act shall take effect in 60 days.
