## AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, providing for the offense of sexual
- assault by sports official.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 18 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 3124.3. Sexual assault by sports official.
- 9 <u>(a) General rule.--Except as provided in section 3121</u>
- 10 <u>(relating to rape)</u>, 3122.1 (relating to statutory sexual
- 11 assault), 3123 (relating to involuntary deviate sexual
- 12 <u>intercourse</u>), 3124.1 (relating to sexual assault) and 3125
- 13 (relating to aggravated indecent assault), a person who serves
- 14 <u>as a sports official in a sports program of a nonprofit</u>
- 15 association or a for-profit association commits a felony of the
- 16 third degree when that person engages in sexual intercourse,
- 17 deviate sexual intercourse or indecent contact with a child

- 1 under 18 years of age who is participating in a sports program
- 2 of the nonprofit association or for-profit association.
- 3 (b) Definitions.--As used in this section, the following
- 4 words and phrases shall have the meanings given to them in this
- 5 <u>subsection unless the context clearly indicates otherwise:</u>
- 6 "Nonprofit association." As defined in 42 Pa.C.S. § 8332.1
- 7 (relating to manager, coach, umpire or referee and nonprofit
- 8 <u>association negligence standard).</u>
- 9 <u>"Sports official." A person who supervises children</u>
- 10 participating in a sports program of a nonprofit association or
- 11 <u>a for-profit association, including, but not limited to, a</u>
- 12 coach, assistant coach, athletic trainer, team attendant, game
- 13 manager, instructor or a person at a sports program who enforces
- 14 the rules of a sporting event sponsored by a sports program of a
- 15 <u>nonprofit association or a for-profit association, including,</u>
- 16 but not limited to, an umpire or referee, whether receiving
- 17 remuneration or holding the position as a volunteer.
- "Sports program." As defined in 42 Pa.C.S. § 8332.1
- 19 (relating to manager, coach, umpire or referee and nonprofit
- 20 association negligence standard).
- 21 Section 2. This act shall take effect in 60 days.
