## AN ACT

- 1 Amending the act of July 2, 1984 (P.L.561, No.112), entitled "An
- act establishing the Pennsylvania Conservation Corps; and
  - making an appropriation," further providing for the
- definitions of "department" and "secretary," "SECRETARY"; AND
- 5 transferring the administration of the Pennsylvania
- 6 Conservation Corps from the Department of Labor and Industry
- 7 to the Department of Conservation and Natural Resources.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:

- 10 Section 1. The definitions of "department" and "secretary"
- 11 in section 2 of the act of July 2, 1984 (P.L.561, No.112), known
- 12 as the Pennsylvania Conservation Corps Act, amended June 25,
- 13 1997 (P.L.339, No.38), are amended to read:
- 14 Section 2. Definitions.
- 15 The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:

- 8 Section 2. Section 3 of the act, amended July 2, 1993
- 9 (P.L.350, No.49), is amended to read:
- 10 Section 3. Pennsylvania Conservation Corps created.
- 11 There is hereby created within the Department of [Labor and
- 12 Industry] <u>Conservation and Natural Resources</u> the Pennsylvania
- 13 Conservation Corps.
- 14 Section 3. The act is amended by adding a section to read:
- 15 Section 12.2. Transfers.
- There are transferred from the Department of Labor and
- 17 Industry to the Department of Conservation and Natural Resources
- 18 all of the following:
- 19 (1) The property, supplies, equipment and records being
- 20 used in the administration of this act.
- 21 (2) The personnel employed in the administration of this
- 22 <u>act.</u>
- 23 (3) The unexpended balances of appropriations,
- 24 allocations and other funds available under this act.
- 25 (4) The rights and obligations of contracts entered into
- 26 under this act.
- 27 Section 4. This act shall take effect in 60 days JULY 1,
- 28 2012.
