AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in the Uniform Firearms Act, further
- providing for licenses and for sale or transfer of firearms.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 6109(c) and 6111(b)(1)of Title 18 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 \ 6109. Licenses.
- 9 * * *
- 10 (c) Form of application and content. -- The application for a
- 11 license to carry a firearm shall be uniform throughout this
- 12 Commonwealth and shall be on a form prescribed by the
- 13 Pennsylvania State Police. The form may contain provisions, not
- 14 exceeding one page, to assure compliance with this section.
- 15 Issuing authorities shall use only the application form
- 16 prescribed by the Pennsylvania State Police. An issuing
- 17 authority may not refuse to issue a license based on the

- 1 applicant's inability to complete the application form without
- 2 assistance if two individuals other than the issuing authority
- 3 <u>attest to completion at the direction of the applicant.</u> One of
- 4 the following reasons for obtaining a firearm license shall be
- 5 set forth in the application: self-defense, employment, hunting
- 6 and fishing, target shooting, gun collecting or another proper
- 7 reason. The application form shall be dated and signed by the
- 8 applicant and shall contain the following statement:
- 9 I have never been convicted of a crime that prohibits me
- from possessing or acquiring a firearm under Federal or
- 11 State law. I am of sound mind and have never been
- 12 committed to a mental institution. I hereby certify that
- 13 the statements contained herein are true and correct to
- 14 the best of my knowledge and belief. I understand that,
- if I knowingly make any false statements herein, I am
- subject to penalties prescribed by law. I authorize the
- sheriff, or his designee, or, in the case of first class
- 18 cities, the chief or head of the police department, or
- his designee, to inspect only those records or documents
- 20 relevant to information required for this application. If
- 21 I am issued a license and knowingly become ineligible to
- legally possess or acquire firearms, I will promptly
- 23 notify the sheriff of the county in which I reside or, if
- I reside in a city of the first class, the chief of
- 25 police of that city.

- 27 § 6111. Sale or transfer of firearms.
- 28 * * *
- 29 (b) Duty of seller.--No licensed importer, licensed
- 30 manufacturer or licensed dealer shall sell or deliver any

- 1 firearm to another person, other than a licensed importer,
- 2 licensed manufacturer, licensed dealer or licensed collector,
- 3 until the conditions of subsection (a) have been satisfied and
- 4 until he has:
- 5 (1) For purposes of a firearm as defined in section 6102
- 6 (relating to definitions), obtained a completed
- 7 application/record of sale from the potential buyer or
- 8 transferee to be filled out in triplicate, the original copy
- 9 to be sent to the Pennsylvania State Police, postmarked via
- first class mail, within 14 days of the sale, one copy to be
- 11 retained by the licensed importer, licensed manufacturer or
- 12 licensed dealer for a period of 20 years and one copy to be
- 13 provided to the purchaser or transferee. The form of this
- application/record of sale shall be no more than one page in
- length and shall be promulgated by the Pennsylvania State
- Police and provided by the licensed importer, licensed
- 17 manufacturer or licensed dealer. No licensed importer,
- 18 licensed manufacturer or licensed dealer may refuse to sell
- or deliver a firearm based on the inability of the potential
- 20 buyer or transferee to complete the application/record
- 21 without assistance if two individuals other than the licensed
- 22 importer, licensed manufacturer or licensed dealer attest to
- 23 completion at the direction of the potential buyer or
- 24 <u>transferee</u>. The application/record of sale shall include the
- 25 name, address, birthdate, gender, race, physical description
- and Social Security number of the purchaser or transferee,
- 27 the date of the application and the caliber, length of
- barrel, make, model and manufacturer's number of the firearm
- 29 to be purchased or transferred. The application/record of
- 30 sale shall also contain the following question:

1 Are you the actual buyer of the firearm(s), as defined 2 under 18 Pa.C.S. § 6102 (relating to definitions), listed 3 on this application/record of sale? Warning: You are not 4 the actual buyer if you are acquiring the firearm(s) on behalf of another person, unless you are legitimately 5 6 acquiring the firearm as a gift for any of the following 7 individuals who are legally eligible to own a firearm: 8 (1)spouse; 9 (2) parent; (3) child; 10 (4) grandparent; or 11 (5) grandchild. 12
