AN ACT

Amending the act of May 3, 1933 (P.L.242, No.86), entitled, as amended, "An act to promote the public health and safety by 2 providing for examination, licensing and granting of permits 3 for those who desire to engage in the profession of 4 cosmetology; defining cosmetology, and regulating cosmetology 5 salons, schools, students, apprentices, teachers, managers, 6 manicurists and cosmetologists; conferring powers and duties 7 upon the Commissioner of Professional and Occupational 8 Affairs in the Department of State; providing for appeals to 9 certain courts by applicants and licensees; and providing 10 penalties," further providing for eligibility for 11 examination. 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 4 of the act of May 3, 1933 (P.L.242, 16 No.86), referred to as the Cosmetology Law, amended July 7, 2006 17 (P.L.704, No.99), is amended to read: 18 Section 4. Eligibility Requirements for Examination .-- No 19 person shall be permitted by the board to take an examination to 20 receive a license as a cosmetologist unless such person (1) 21 shall be at least sixteen years of age and of good moral

character at the time of making application, and (2) shall have

- 1 completed a tenth grade education or the equivalent thereof, or
- 2 in lieu of such education or the equivalent thereof shall have
- 3 received training from or under the auspices of the Bureau of
- 4 Rehabilitation in the Department of Labor and Industry, and (3)
- 5 shall have either (i) completed not less than one thousand two
- 6 hundred fifty hours as a student in a duly registered school of
- 7 cosmetology as hereinafter provided in this act, or (ii) shall
- 8 have been registered and served as an apprentice at least two
- 9 thousand hours in a licensed cosmetology salon as hereinafter
- 10 provided in this act. The application shall be accompanied by a
- 11 notarized statement from either the licensed cosmetology school
- 12 the applicant attended or the licensed cosmetology teacher in
- 13 the licensed cosmetology salon where the applicant studied and
- 14 trained, stating that the applicant has completed the study and
- 15 training period required under this act. No person shall be
- 16 permitted to take an examination for a license to teach
- 17 cosmetology or natural hair braiding, nail technology or
- 18 esthetics unless such person shall have a license to practice
- 19 cosmetology or a limited license, be at least eighteen years of
- 20 age, shall have completed a twelfth grade education or the
- 21 equivalent thereof and have had five hundred hours of
- 22 specialized training as set forth in section 6 of this act which
- 23 hours shall be in addition to the hours necessary to qualify for
- 24 a license to practice cosmetology or a limited license.
- 25 Notwithstanding clause (3)(i), an applicant shall be permitted
- 26 to take the theoretical part of the examination upon completion
- 27 of at least nine hundred hours of instruction in a duly
- 28 <u>registered school of cosmetology.</u>
- 29 Section 2. This act shall take effect in 60 days.
