AN ACT

- 1 Designating Grant Street from Main Street in Waynesboro Borough,
- 2 Franklin County, to the borough line at Route 316 as the
- 3 Staff Sergeant Richard J. Tieman Memorial Highway.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Staff Sergeant Richard J. Tieman Memorial Highway.
- 7 (a) Findings. -- The General Assembly finds and declares as
- 8 follows:
- 9 (1) Staff Sqt. Richard James Tieman, 28, of Waynesboro
- 10 was killed in Kabul, Afghanistan, on May 17, 2010, during the
- 11 deadliest attack on NATO forces this year.
- 12 (2) Staff Sqt. Tieman served with U.S. Army Europe and

- 1 was stationed in Heidelberg, Germany. Four other soldiers
- 2 from his unit were killed. He was the detachment NCO for Lt.
- Gen. David Rodriguez, who directs the day-to-day operations
- 4 of coalition forces across Afghanistan.
- 5 (3) Staff Sgt. Tieman was in charge of the convoy and
- only had two months left before he returned home for at least
- 7 three years. He was sent to Afghanistan in August 2009.
- 8 (4) Staff Sqt. Tieman was born on an Army base in
- 9 November 1981. His father was a master sergeant with the
- 10 United States Army and served in the military for 25 years.
- 11 (5) Staff Sqt. Tieman, who attended Waynesboro schools,
- joined the Army in 2000 and was first stationed at Fort Hood,
- 13 Texas, according to his family. He then was stationed in
- 14 Bamberg, Germany, and at Fort Riley, Kansas. He was first
- sent overseas for the 2003 invasion of Iraq and was there
- until 2004. He then served from 2006 to 2007 and returned for
- the third time in August 2009.
- 18 (6) Staff Sgt. Tieman and Staff Sgt. Paulina Tieman were
- married in April, 2011, and had planned a large wedding for
- 20 this December when they both returned home. Paulina is
- 21 currently stationed at Fort Riley.
- 22 (b) Designation.--Grant Street from Main Street in
- 23 Waynesboro Borough, Franklin County, to the borough line at
- 24 Route 316, is hereby designated as the Staff Sqt. Richard J.
- 25 Tieman Memorial Highway.
- 26 (c) Signs.--The Department of Transportation shall erect and
- 27 maintain appropriate signs displaying the name of the highway
- 28 designated under subsection (b) to traffic in both directions.
- 29 Section 2. Effective date.
- 30 This act shall take effect in 60 days.
