## AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, defining the offense of theft of
- 3 secondary metal; and prescribing penalties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 18 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 3935. Theft of secondary metal.
- 9 (a) Offense defined. -- A person commits the offense of theft
- 10 of secondary metal if the person unlawfully takes or attempts to
- 11 take possession of, carries away or exercises unlawful control
- 12 over any secondary metal with intent to deprive the rightful
- 13 <u>owner thereof</u>.
- 14 (b) Grading.--Except as set forth in subsection (c):
- 15 (1) An offense under this section constitutes a
- 16 misdemeanor of the third degree when the value of the
- 17 secondary metal unlawfully obtained is less than \$50.

- 1 (2) When the value of the secondary metal unlawfully
- 2 <u>obtained is \$50 or more but less than \$200 the offense</u>
- 3 <u>constitutes a misdemeanor of the second degree.</u>
- 4 (3) When the value of the secondary metal unlawfully
- 5 <u>obtained is \$200 or more but less than \$1,000 the offense</u>
- 6 <u>constitutes a misdemeanor of the first degree.</u>
- 7 (4) When the value of the secondary metal unlawfully
- 8 <u>obtained is \$1,000 or more, the offense constitutes a felony</u>
- 9 <u>of the third degree.</u>
- 10 (c) Third or subsequent offenses. -- An offense under this
- 11 <u>section constitutes a felony of the third degree when the</u>
- 12 offense is a third or subsequent offense, regardless of the
- 13 value of the secondary metal. For purposes of this subsection, a
- 14 first offense includes a conviction, acceptance of Accelerated
- 15 Rehabilitative Disposition or other form of preliminary
- 16 <u>disposition before the sentencing on the present violation for</u>
- 17 an offense under this section or an offense substantially
- 18 similar to an offense under this section.
- 19 (d) Definition. -- As used in this section, the term
- 20 "secondary metal" means wire or cable commonly used by
- 21 communications and electrical utilities, copper, aluminum or
- 22 other metal, or a combination of metals, that is valuable for
- 23 recycling or reuse as raw material.
- 24 Section 2. This act shall take effect in 60 days.
