AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 1 Statutes, in general provisions, further providing for 2 definitions; and in registration of vehicles, further 3 providing for vehicles exempt from registration. 4 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 7 Section 1. The definition of "multipurpose agricultural vehicle" in section 102 of Title 75 of the Pennsylvania 8 Consolidated Statutes is amended to read: 9 § 102. Definitions. 10 11 Subject to additional definitions contained in subsequent 12 provisions of this title which are applicable to specific 13 provisions of this title, the following words and phrases when 14 used in this title shall have, unless the context clearly 15 indicates otherwise, the meanings given to them in this section: 16 * * *

1 "Multipurpose agricultural vehicle." A motor vehicle which is [60] <u>62</u> inches or less in width and [1,200] <u>2,000</u> pounds or 2 less in dry weight and which is used exclusively for 3 agricultural operations and only incidentally operated or moved 4 upon the highways. 5 6 * * * Section 2. Section 1302(17) of Title 75 is amended to read: 7 8 § 1302. Vehicles exempt from registration. 9 The following types of vehicles are exempt from registration: * * * 10 (17) Any multipurpose agricultural vehicle. Vehicles 11 exempt from registration under this paragraph shall be used 12 13 exclusively upon a farm or farms owned or operated by the 14 owner of the vehicles or upon highways between: 15 (i) Parts of one such farm. (ii) Such farms located not more than [two] five 16 17 miles apart. * * * 18 19 Section 3. This act shall take effect in 60 days.
