AN ACT

- Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of controlled substances, other drugs, devices and cosmetics; 3 conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, 5 Device and Cosmetic Board; establishing schedules of 6 7 controlled substances; providing penalties; requiring registration of persons engaged in the drug trade and for the 8 revocation or suspension of certain licenses and 9 registrations; and repealing an act," providing for criminal 10 11 immunity. 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- Section 1. The act of April 14, 1972 (P.L.233, No.64), known 14
- 15 as The Controlled Substance, Drug, Device and Cosmetic Act, is
- 16 amended by adding a section to read:
- 17 Section 13.6. Criminal Immunity. -- (a) The following persons
- shall be barred from being arrested, charged, prosecuted or 18
- 19 convicted for committing a prohibited act under section 13:

- 1 (1) A person who, in good faith, seeks medical assistance
- 2 <u>for a person experiencing a drug overdose.</u>
- 3 (2) A person who experiences a drug overdose and seeks
- 4 medical assistance.
- 5 (3) A person who is subject to a good faith request for
- 6 <u>medical assistance due to a drug overdose.</u>
- 7 (b) As used in this section, the term "drug overdose" means
- 8 an acute condition caused from the use of a drug as defined
- 9 <u>under section 2, which results in physical illness, coma, mania,</u>
- 10 hysteria or death.
- 11 Section 2. This act shall take effect in 60 days.
