AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
 Statutes, in registration of vehicles, providing for special
 registration plates for recipients of the Silver Star, Bronze
 Star and Bronze Star with Valor AND FOR SPECIAL PLATES FOR
 RECIPIENTS OF DISTINGUISHED SERVICE CROSS, DISTINGUISHED
 FLYING CROSS, NAVY CROSS OR AIR FORCE CROSS.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Title 75 of the Pennsylvania Consolidated
- 10 Statutes is amended by adding sections to read:
- 11 § 1366. Special plates for recipients of Silver Star.
- 12 Upon application of any person who is a recipient of the
- 13 <u>Silver Star, accompanied by a fee of \$20 \$10 which shall be in</u>
- 14 addition to the annual registration fee and by such
- 15 <u>documentation as the department shall require</u>, the department
- 16 shall issue to the person a special registration plate
- 17 <u>designating the vehicle so licensed as belonging to a person who</u>
- 18 is a recipient of the Silver Star. The special registration

- 2 registered gross weight of not more than 10,000 14,000 pounds.

- 19 <u>shall issue to the person a special registration plate</u>
- 20 designating the vehicle so licensed as belonging to a person who
- 21 is a recipient of the Bronze Star for Valor. The special

- 26 CROSS, DISTINGUISHED FLYING CROSS, NAVY CROSS OR AIR

- 28 UPON APPLICATION OF ANY PERSON WHO IS A RECIPIENT OF THE
- 29 <u>DISTINGUISHED SERVICE CROSS, DISTINGUISHED FLYING CROSS, NAVY</u>
- 30 CROSS OR AIR FORCE CROSS, ACCOMPANIED BY A FEE OF \$10 WHICH

- 1 SHALL BE IN ADDITION TO THE ANNUAL REGISTRATION FEE AND BY SUCH_
- 2 DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE DEPARTMENT
- 3 SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION PLATE
- 4 <u>DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A PERSON WHO</u>
- 5 IS A RECIPIENT OF THE DISTINGUISHED SERVICE CROSS, DISTINGUISHED
- 6 FLYING CROSS, NAVY CROSS OR AIR FORCE CROSS. THE SPECIAL
- 7 REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR OR TRUCK
- 8 WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 14,000 POUNDS.
- 9 Section 2. This act shall take effect in 120 days.
