AN ACT

- Authorizing the Department of General Services, with the approval of the Department of Conservation and Natural 2 3 Resources and the Governor, to grant and convey to East Norriton Township certain lands situate in East Norriton 4 5 Township, Montgomery County, in exchange for East Norriton Township's granting and conveying certain lands to the 6 Commonwealth of Pennsylvania to be added to the existing 7 lands of the Norristown Farm Park; authorizing the Department 8 of General Services, with the approval of the Department of 9 Conservation and Natural Resources and the Governor, to 10 remove the deed restrictions on a portion of the lands 11 previously conveyed by the Department of General Services in 12 accordance with section 1(c) of the act of July 10, 1985 13 (P.L.201, No.51); and authorizing East Norriton Township to 14 15 convey the property it receives from the Commonwealth of 16 Pennsylvania pursuant to this act to Montgomery County for nominal consideration for public highway improvements. 17 The General Assembly of the Commonwealth of Pennsylvania 18 19 hereby enacts as follows: 20 Section 1. Conveyance in East Norriton Township, Montgomery 21 County. 22 Authorization. -- The Department of General Services, with 23 the approval of the Department of Conservation and Natural 24 Resources and the Governor, is hereby authorized on behalf of 25 the Commonwealth of Pennsylvania to grant and convey to East
- 26 Norriton Township, certain lands situate in East Norriton

- 1 Township, Montgomery County, in exchange for the conveyance of a
- 2 certain parcel of property from East Norriton Township in
- 3 accordance with subsection (c).
- 4 (b) Property description. -- The property to be conveyed in
- 5 accordance with subsection (a) consists of three tracts of land
- 6 totaling approximately 1.907 acres and improvements thereon
- 7 bounded and more particularly described as follows:

- 15 (e) Conditions. -- The conveyances shall be made concurrently
- 16 and under and subject to all lawful and enforceable easements,
- 17 servitudes and rights of others, including but not confined to
- 18 streets, roadways and rights of any telephone, telegraph, water,
- 19 electric, gas or pipeline companies, as well as under and
- 20 subject to any lawful and enforceable estates or tenancies
- 21 vested in third persons appearing of record, for any portion of
- 22 the land or improvements erected thereon.
- 23 (f) Deed restrictions. -- Any conveyance authorized under
- 24 subsections (a) and (c) shall be made under and subject to the
- 25 condition, which shall be contained in the deed of conveyance,
- 26 that no portion of the property conveyed shall be used as a
- 27 licensed facility, as defined in 4 Pa.C.S. § 1103 (relating to
- 28 definitions), or any other similar type of facility authorized
- 29 under State law. The condition shall be a covenant running with
- 30 the land and shall be binding upon the Grantee, its successors

- 1 and assigns. Should the Grantee, its successors or assigns,
- 2 permit any portion of the property authorized to be conveyed in
- 3 this act to be used in violation of this subsection, the title
- 4 shall immediately revert to and revest in the Grantor.
- 5 (g) Removal of deed restrictions. -- The Department of General
- 6 Services, with the approval of the Department of Conservation
- 7 and Natural Resources and the Governor, is authorized to remove
- 8 the deed restrictions on a portion of the lands conveyed to the
- 9 East Norriton Fire Company, now known as Norriton Fire Engine
- 10 Company, by the Department of General Services under the
- 11 authority contained in section (1)(c) of the act of July 10,
- 12 1985 (P.L.201, No.51), entitled "An act authorizing the
- 13 conveyance of certain State land to the East Norriton Fire
- 14 Company in Montgomery County; and making a repeal." The
- 15 Department of General Services, on behalf of the Commonwealth of
- 16 Pennsylvania, is hereby authorized to execute any legal
- 17 instruments necessary to remove the aforementioned deed
- 18 restrictions on the following portion of land located in East
- 19 Norriton Township, Montgomery County, for the sole purpose of
- 20 making the land available to East Norriton Township and/or
- 21 Montgomery County for widening those respective township and
- 22 county roads described as:
- 23 Germantown Pike (County Road).
