8	Section 1. Sections 5505 and 6308(b) of Title 18 of the
9	Pennsylvania Consolidated Statutes are amended to read:
10	§ 5505. Public drunkenness and similar misconduct.
11	A person is guilty of a summary offense if he appears in any
12	public place manifestly under the influence of alcohol or a
13	controlled substance, as defined in the act of April 14, 1972
14	(P.L.233, No.64), known as The Controlled Substance, Drug,
15	Device and Cosmetic Act, except those taken pursuant to the
16	lawful order of a practitioner, as defined in The Controlled
17	Substance, Drug, Device and Cosmetic Act, to the degree that he
18	may endanger himself or other persons or property, or annoy

persons in his vicinity. A person convicted of violating this 1 section may be sentenced to pay a fine of not more than \$1,000 2 ← \$500 FOR THE FIRST VIOLATION AND NOT MORE THAN \$1,000 FOR THE 3 SECOND AND EACH SUBSEQUENT VIOLATION. 4 § 6308. The amendment of 18 Pa.C.S. §§ 5505 and 6308(b) shall apply to offenses committed on or after the effective date 16 17 of this section. 18 Section 3. This act shall take effect in 60 days.
