## AN ACT

Providing for the adoption of capital projects related to the repair, rehabilitation or replacement of highway bridges and 2 for disaster assistance projects to be financed from debt 3 incurred under clause (1) or (4) of subsection (a) of section 7 of Article VIII of the Constitution of Pennsylvania. 5 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 CHAPTER 1 9 PRELIMINARY PROVISIONS Section 101. - 16 The total authorization for the projects itemized pursuant to
- 17 this chapter and to be financed from debt incurred under clause
- 18 (1) OR (4) of subsection (a) of section 7 of Article VIII of the
- 19 Constitution of Pennsylvania is \$10,000,000 \$8,901,000.

- 27 chapter for any project shall not supplant or replace any
- 28 Federal funds authorized by any Federal law or regulation.
- 29 Funding from this chapter for any project is available only to
- 30 the extent that Federal funds are not available for such

- 2 (b) Continuity with bridge supplementals. -- The provisions of
- 3 this chapter shall be construed unless specifically provided
- 4 otherwise as a supplement to the act of December 8, 1982
- 5 (P.L.848, No.235), known as the Highway-Railroad and Highway
- 6 Bridge Capital Budget Act for 1982-1983.
- 7 Section 375. Allocation of funds.
- 8 Whenever the Department of Transportation determines that the
- 9 full estimated financial costs of the projects itemized in this
- 10 chapter are not necessary for the proper design, acquisition or
- 11 construction of such project, the excess funds no longer
- 12 required may be allocated by the department to increase the
- 13 estimated costs of any one or more of the projects specifically
- 14 itemized in a capital budget.
- 15 CHAPTER 5
- 16 RAILROAD DISASTER ASSISTANCE PROJECTS
- 17 Section 501. Short title of chapter.
- 18 This chapter shall be known and may be cited as the Railroad
- 19 Disaster Assistance Projects Itemization Act of 2011.
- 20 Section 502. Definitions.
- 21 The following words and phrases when used in this chapter
- 22 shall have the meanings given to them in this section unless the
- 23 context clearly indicates otherwise:
- "Disaster." The period of time in calendar year 2011
- 25 relating to Hurricane Irene and Tropical Storm Lee that was the
- 26 subject of a presidential declaration of an emergency under The
- 27 Robert T. Stafford Disaster Relief and Emergency Assistance Act
- 28 (Public Law 93-288, 88 Stat. 143).
- 29 Section 503. Total authorization.
- 30 The total authorization for disaster assistance projects to

- 1 be financed in part with grants as itemized in this chapter is

- 5 The individual disaster mitigation or assistance projects to
- 6 be financed from debt are hereby itemized, together with their
- 7 respective estimated financial costs, as follows:
- 8 Department of Transportation \$2,000,000
- 9 DEPARTMENT OF TRANSPORTATION \$1,000,000
- 10 (1) Lycoming Valley Railroad \$1,000,000
- 11 Section 505. Funds.
- 12 The projects itemized in this chapter shall be funded from
- 13 debt incurred under the provisions of clause (1) or (4) of
- 14 subsection (a) of section 7 of Article VIII of the Constitution
- 15 of Pennsylvania.
- 16 Section 506. Federal funds.
- 17 All moneys received from the Federal Government for the
- 18 projects specifically itemized in this chapter are also hereby
- 19 appropriated for those projects.
- 20 Section 507. Construction.
- 21 Amounts contained in this chapter for any project shall not
- 22 supplant or replace any Federal funds authorized by any Federal
- 23 law or regulation. Funding from this chapter for any project is
- 24 available only to the extent that Federal funds are not
- 25 available for such project.
- 26 CHAPTER 7
- 27 MISCELLANEOUS PROVISIONS
- 28 Section 701. Effective date.
- 29 This act shall take effect immediately.
