| 9 | Section 1. The act of March 10, 1949 (P.L.30, No.14), known |
| 10 | as the Public School Code of 1949, is amended by adding a |

| 12 | Section 1554. Holocaust, Genocide and Human Rights |
| 13 | <u>Violations Instruction(a) Beginning with school year</u> |
| 14 | 2014-2015 and each school year thereafter, each public school |
| 15 | student shall receive mandatory instruction in the Holocaust, |
| 16 | genocide and human rights violations from grade six (6) through |
| 17 | grade twelve (12). The instruction shall be integrated within |
| 18 | the social studies and language arts courses of study required |
| 19 | in accordance with the State Board of Education regulations. |
| 20 | Instruction may also be integrated into other appropriate |

| 17 | guidelines no later than twelve (12) months after the effective |

| 21 | (i) The breadth of the history of the Holocaust, including |

| 23 | persecution of Jews and non-Jews, Jewish and non-Jewish |
| 24 | resistance and post-World War II trials. |
| 25 | (ii) The definition, history, response and actions taken in |

| 28 | (iv) Anti-Semitism, racism and the abridgment of civil |
