## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," further providing for Office for Safe
- 6 Schools.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1302-A(b) and (c) of the act of March 10,
- 10 1949 (P.L.30, No.14), known as the Public School Code of 1949,
- 11 amended November 17, 2010 (P.L.996, No.104), are amended to
- 12 read:
- 13 Section 1302-A. Office for Safe Schools.--\* \* \*
- 14 (b) The office shall have the power and duty to implement
- 15 the following:
- 16 (1) To coordinate antiviolence efforts between school,
- 17 professional, parental, governmental, law enforcement and
- 18 community organizations and associations.
- 19 (2) To collect, develop and disseminate information,

- 1 policies, strategies and other information to assist in the
- 2 development of programs to impact school violence.
- 3 (2.1) To direct all school entities to submit annual school
- 4 violence statistics and reports to the office no later than July
- 5 31 of each year.
- 6 (3) To provide direct training to school employes, parents,
- 7 law enforcement officials and communities on effective measures
- 8 to prevent and combat school violence.
- 9 (4) To advise school entities and nonpublic schools on the
- 10 development of policies to be used regarding possession of
- 11 weapons by any person, acts of violence and protocols for
- 12 coordination with and reporting to law enforcement officials and
- 13 the Department of Education.
- 14 (4.1) To verify the existence of corrective action plans to
- 15 reduce incidents of violence as required in the No Child Left
- 16 Behind Act of 2001 (Public Law 107-110, 115 Stat. 1425).
- 17 (5) To develop forms to be used by school entities and
- 18 police departments for reporting incidents involving acts of
- 19 violence and possession of weapons on school property. The forms
- 20 shall be reviewed on a biennial basis and revised when
- 21 necessary.
- 22 (6) To verify that each school entity has a biennially
- 23 updated and reexecuted memorandum of understanding with local
- 24 law enforcement and has filed such memorandum with the office on
- 25 a biennial basis.
- 26 (7) To publish and post on the Department of Education's
- 27 Internet website a School Safety Annual Report no later than
- 28 November 1 of each calendar year outlining all incidents
- 29 required to be reported under section 1303-A and any school
- 30 district that failed to submit a report under section 1303-A.

- 1 (8) Not later than January 2, 2013, to establish an antigang
- 2 counseling program to provide materials, support and financial
- 3 assistance to participating school districts to establish pilot
- 4 programs designed to educate students and parents on the
- 5 following:
- 6 (i) The extent to which criminal gang activity exists in the
- 7 school district's community and the types of activity that
- 8 criminal gangs engage in or promote.
- 9 (ii) The negative societal impacts that criminal gangs have
- 10 on a community, including criminal activity.
- 11 (iii) Methods to discourage participation in criminal gangs.
- 12 (iv) The consequences of criminal gang activity, including
- 13 consequences in the criminal justice system for participating in
- 14 criminal gangs.
- 15 (9) To encourage the use of community resources not directly
- 16 <u>affiliated with the school district</u>, including the participation
- 17 of law enforcement officials in a pilot program under paragraph
- 18 (8).
- 19 \* \* \*
- 20 (c) In addition to the powers and duties set forth under
- 21 subsection (b), the office is authorized to make targeted grants
- 22 to school entities to fund programs which address school
- 23 violence, including:
- 24 (1) Conflict resolution or dispute management, including
- 25 restorative justice strategies.
- 26 (1.1) School-wide positive behavior support that includes
- 27 primary or universal, secondary and tertiary supports and
- 28 interventions in school entities.
- 29 (1.2) School-based diversion programs.
- 30 (2) Peer helpers programs.

- 1 (3) Risk assessment, safety-related, violence prevention
- 2 curricula, including, but not limited to, dating violence
- 3 curricula and restorative justice strategies.
- 4 (4) Classroom management.
- 5 (5) Student codes of conduct.
- 6 (6) Training to undertake a districtwide assessment of risk
- 7 factors that increase the likelihood of problem behaviors among
- 8 students.
- 9 (7) Development and implementation of research-based
- 10 violence prevention programs that address risk factors to reduce
- 11 incidents of problem behaviors among students including, but not
- 12 limited to, bullying.
- 13 (8) Comprehensive, districtwide school safety and violence
- 14 prevention plans.
- 15 (9) Security planning, purchase of security-related
- 16 technology which may include metal detectors, protective
- 17 lighting, surveillance equipment, special emergency
- 18 communications equipment, electronic locksets, deadbolts and
- 19 theft control devices and training in the use of security-
- 20 related technology. Security planning and purchase of security-
- 21 related technology shall be based on safety needs identified by
- 22 the school entity's board of directors.
- 23 (10) Institution of student, staff and visitor
- 24 identification systems, including criminal background check
- 25 software.
- 26 (11) Establishment or enhancement of school security
- 27 personnel, including school resource officers.
- 28 (12) Provision of specialized staff and student training
- 29 programs, including training for Student Assistance Program team
- 30 members in elementary, middle and high schools in the referral

- 1 of students at risk of violent behavior to appropriate
- 2 community-based services, including mental health services.
- 3 (13) Alternative education programs provided for in Article
- 4 XIX-C.
- 5 (14) Counseling services for students enrolled in
- 6 alternative education programs.
- 7 (15) An Internet web-based system for the management of
- 8 student discipline, including misconduct and criminal offenses.
- 9 (16) Staff training programs in the use of positive behavior
- 10 supports, de-escalation techniques and appropriate responses to
- 11 student behavior that may require immediate intervention.
- 12 (17) Antigang pilot programs.

- 14 Section 2. This act shall take effect in 60 days.
