AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 1 "An act providing for and reorganizing the conduct of the 2 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 3 4 departments, boards, commissions, and officers thereof, 5 including the boards of trustees of State Normal Schools, or 6 7 Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative 8 departments, boards, and commissions; defining the powers and 9 duties of the Governor and other executive and administrative 10 officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 16 other assistants and employes in certain departments, boards, 17 and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and 18 19 commissions shall be determined," eliminating authority for 20 the fair share fee for employees of Commonwealth entities; 21 and relieving certain employee organizations of certain 22 duties and obligations. 23

24 The General Assembly of the Commonwealth of Pennsylvania

25 hereby enacts as follows:

26 Section 1. The definitions of "Commonwealth" and "public

employer" in section 2215 of the act of April 9, 1929 (P.L.177, 1 No.175), known as The Administrative Code of 1929, added July 2 13, 1988 (P.L.493, No.84), are amended to read: 3 4 Section 2215. Fair Share Fee; Payroll Deduction.--(a) As used in this section, the following words and phrases shall have 5 the meanings given to them in this subsection: 6 * * * 7 ["Commonwealth" shall mean the Commonwealth of Pennsylvania, 8 9 including any board, commission, department, agency or 10 instrumentality of the Commonwealth.] * * * 11 "Public employer" shall mean [the Commonwealth of 12 13 Pennsylvania or] a school entity. * * * 14 15 Section 2. No collective bargaining agreement made after the effective date of this section by any Commonwealth entity as 16 formerly defined in section 2215 of the act nor any extension of 17 18 an existing collective bargaining agreement made after the 19 effective date of this section may require payment of a fair 20 share fee to the exclusive representative by a nonmember of the

21 exclusive representative.

22 Section 3. This act shall take effect immediately.
