AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the 2 Executive Department thereof and the administrative 3 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 4 5 Teachers Colleges; abolishing, creating, reorganizing or 6 7 authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and 8 duties of the Governor and other executive and administrative 9 officers, and of the several administrative departments, 10 boards, commissions, and officers; fixing the salaries of the 11 Governor, Lieutenant Governor, and certain other executive 12 and administrative officers; providing for the appointment of 13 certain administrative officers, and of all deputies and 14 other assistants and employes in certain departments, boards, 15 and commissions; and prescribing the manner in which the 16 17 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 18 commissions shall be determined," in Department of Aging, 19 further providing for the allocation of resources. 20 21 The General Assembly of the Commonwealth of Pennsylvania
