AN ACT

- 1 Providing for limited immunity for persons that sponsor farm-2 related tourism activities.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Agritourism
- 7 Immunity Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Agritourism activity." A farm-related tourism activity,
- 13 regardless of whether a fee is charged, which:
- 14 (1) takes place on real property otherwise USED
- 15 PRIMARILY FOR THE PURPOSE OF engaging in a normal
- 16 agricultural operation; and

- 1 (2) is designed for recreational, entertainment or
- 2 educational purposes.
- 3 The term includes, but is not limited to, a corn maze, a hay
- 4 maze, farm tours, a select and cut-your-own Christmas tree
- 5 operation and a pick-your-own-crop operation.
- 6 "AGRITOURISM OPERATOR." A PERSON THAT SPONSORS, ORGANIZES, <--
- 7 CONDUCTS OR PROVIDES FACILITIES FOR AN AGRITOURISM ACTIVITY.
- 8 "INHERENT RISKS OF AGRITOURISM ACTIVITY." THE DANGERS OR
- 9 CONDITIONS THAT ARE AN INTEGRAL PART OF AN AGRITOURISM ACTIVITY,
- 10 INCLUDING CERTAIN HAZARDS, SUCH AS SURFACE OR SUBSURFACE
- 11 CONDITIONS, NATURAL CONDITIONS OF LAND, VEGETATION AND WATERS,
- 12 THE BEHAVIOR OF ANIMALS AND THE ORDINARY DANGERS OF STRUCTURES
- 13 OR EQUIPMENT ORDINARILY USED IN A NORMAL AGRICULTURAL OPERATION.
- "Normal agricultural operation." As defined in section 2 of
- 15 the act of June 10, 1982 (P.L.454, No.133), referred to as the
- 16 Right-to-Farm Law.
- 17 "Operator." A person that sponsors, organizes, conducts or <--
- 18 provides facilities.
- 19 Section 3. Immunity.
- 20 (a) Scope. -- Immunity under this section applies to a person
- 21 if all of the following apply:
- 22 (1) The person is an operator of an agritourism activity <--

- 23 AGRITOURISM OPERATOR.
- 24 (2) The following notice is conspicuously posted in at <--
- 25 least two locations AT THE ENTRANCE TO AND IN AT LEAST ONE
- 26 OTHER LOCATION on the premises where the agritourism activity
- 27 takes place on a sign at least three feet by two feet:
- 28 You assume the risk of agritourism activities under-
- 29 Pennsylvania law.
- 30 UNDER PENNSYLVANIA LAW, AN AGRITOURISM OPERATOR IS NOT <

- 1 LIABLE FOR INJURY TO OR DEATH OF A PARTICIPANT IN AN
- 2 AGRITOURISM ACTIVITY CONDUCTED AT THIS LOCATION IF SUCH
- 3 INJURY OR DEATH RESULTS FROM THE INHERENT RISKS OF THE
- 4 AGRITOURISM ACTIVITY. INHERENT RISKS INCLUDE, AMONG OTHER
- 5 THINGS, RISKS FROM THE CONDITION OF LAND, OPERATION OF
- 6 EQUIPMENT AND BEHAVIOR OF ANIMALS. YOU ARE ASSUMING THE
- 7 RISK OF PARTICIPATING IN THIS AGRITOURISM ACTIVITY.
- 8 (b) Grant.--A person that meets the requirements of
- 9 subsection (a) shall be immune from liability in a negligence
- 10 action for personal injury or death to a participant in the
- 11 agritourism activity who is injured or killed as a result of

- 12 that participation if the participant voluntarily and THAT
- 13 PARTICIPATION IF ALL OF THE FOLLOWING APPLY:
- 14 (1) THE PARTICIPANT VOLUNTARILY AND intelligently
- undertakes participation in the agritourism activity.
- 16 (2) THE PERSONAL INJURY OR DEATH RESULTS FROM THE
- 17 INHERENT RISKS OF THE AGRITOURISM ACTIVITY.
- 18 Section 19. Applicability.
- 19 This act shall apply to any cause of action which arises on
- 20 or after the effective date of this section.
- 21 Section 20. Effective date.
- This act shall take effect in 60 days.
