AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating 4 and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; 7 imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 elections," further providing for notice of November 11 elections; providing for early voting; and further providing 12 for duties of election officials. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 1201 of the act of June 3, 1937 17 (P.L.1333, No.320), known as the Pennsylvania Election Code, 18 amended July 14, 1961 (P.L.647, No.333), is amended to read: 19 Section 1201. Notice of November Elections. -- The county board of each county shall, not earlier than [ten] fifteen days 20 nor later than [three] nine days before each November election, 21

- 1 give notice of the same by newspaper publication in the county
- 2 in accordance with the provisions of section 106 of this act,
- 3 said notice to be published twice in counties of the first class
- 4 and once in all other counties. Such notice shall set forth--(a)
- 5 the officers to be elected in the State at large, or in said
- 6 county, or in any district of which said county or part thereof
- 7 forms a part, or in any city, borough, township, school
- 8 district, poor district, ward or other district which is
- 9 contained in such county; (b) the names of the candidates for
- 10 election to Federal, State, county and city offices, whose names
- 11 will appear upon the ballots or ballot labels; (c) the text of
- 12 all constitutional amendments and other questions to be
- 13 submitted at such election; (d) the places at which the election
- 14 is to be held in the various election districts of the county;
- 15 and (e) the date of the election and the hours during which the
- 16 polls will be open. Such notice may include a portion of the
- 17 form of ballot or diagram of the face of the voting machine in
- 18 reduced size.
- 19 Section 2. The act is amended by adding sections to read:
- 20 Section 1201.3. Early Voting Period. -- Notwithstanding any
- 21 other provision of this act to the contrary, the county board of
- 22 <u>each county shall provide for early voting to begin eight days</u>
- 23 prior to the dates of elections established in accordance with
- 24 Article VI. The early voting period shall end seven days after
- 25 the early voting start date.
- 26 Section 1201.4. Early Voting Sites. -- (a) The county board
- 27 of each county shall designate early voting sites where electors
- 28 may cast their ballots during the early voting period
- 29 <u>established in accordance with section 1201.3.</u>
- 30 (b) The early voting sites shall include the office of the

- 1 county board of elections and sites designated by the county
- 2 board within the election district. The early voting sites shall
- 3 <u>be geographically located to provide electors in the election</u>
- 4 <u>district an equal opportunity to cast a ballot. Aside from the</u>
- 5 office of the county board of elections, the county board is
- 6 prohibited from designating early voting sites outside the
- 7 geographical boundary of election districts within their county.
- 8 The county board shall make available at these sites the same
- 9 cards of instructions and supplies required under section 1202
- 10 of this act.
- 11 (c) During the early voting period, the county board shall
- 12 appoint, in the same manner, clerks of elections and machine
- 13 <u>inspectors at each designated early voting polling place as</u>
- 14 provided for under Article IV.
- 15 Section 1203.1. Meeting of Election Officers for Early
- 16 Voting; Voter's Certificates. -- (a) The provisions of section
- 17 1208 regarding meeting of election officers shall apply to the
- 18 <u>early voting period</u>.
- 19 (b) At each early voting site, the county board shall
- 20 prepare a suitable number of voter's certificates as provided
- 21 for in section 1203. Each elector who appears to vote at an
- 22 early voting site shall complete a voter certificate and shall
- 23 present to an election officer one of the forms of photo
- 24 <u>identification as established in section 1210</u>, if such photo
- 25 <u>identification is required.</u>
- 26 Section 1205.1. Days and Times for Opening and Closing Polls
- 27 at Early Voting Sites. -- The county board of each county shall
- 28 designate the early voting sites to be open from 8 A. M. to 7 P.
- 29 M. each weekday during the early voting period and from 1 P. M.
- 30 to 5 P. M. on Saturday and Sunday during the early voting

- 1 period. Early voting sites shall allow any person in line at the
- 2 <u>closing of an early voting site to cast a vote.</u>
- 3 Section 1205.2. Extending Absentee Eligibility. -- A qualified
- 4 <u>elector</u>, as defined in section 102, shall continue to be
- 5 <u>eligible for an absentee ballot if the qualified elector is</u>
- 6 <u>expected to be absent from his election district during the</u>
- 7 <u>early voting period and on election day and meets the conditions</u>
- 8 under section 102(w).
- 9 Section 3. Section 1225 of the act is amended by adding
- 10 subsections to read:
- 11 Section 1225. Signing and Disposition of Returns, District
- 12 Register and Voting Check List; Posting; Return of Ballot
- 13 Boxes.--* * *
- 14 (d) During early voting periods, each judge of elections
- 15 shall make the voter check list available no later than twelve
- 16 o'clock noon of each day and shall be contemporaneously provided
- 17 to the Secretary of the Commonwealth but shall not tabulate
- 18 votes prior to the close of the polls on election day. The
- 19 ballot of each elector voting early shall be counted even if the
- 20 elector dies on or before election day. The county board shall
- 21 maintain a voting check list in such a way to ensure that
- 22 electors are prohibited from casting additional ballots at
- 23 either an early voting site or on election day in their
- 24 precinct.
- 25 (e) Each early voting site designated by the county board
- 26 shall submit a detailed report of security procedures to secure
- 27 the ballots prior to the early voting period to the Secretary of
- 28 the Commonwealth.
- 29 Section 4. This act shall take effect in 60 days.
