- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, further providing for special registration plates
- generally and for personal registration plates; providing for
- 4 PERSONAL ORGANIZATION REGISTRATION PLATES AND FOR Appalachian <--
- 5 Trail organization registration plates; and making editorial
- 6 changes.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Sections 1333(b.1) and 1341 of Title 75 of the
- 10 Pennsylvania Consolidated Statutes are amended to read:
- 11 § 1333. Lost, stolen, damaged or illegible registration plate.
- 12 * * *
- 13 (b.1) Illegible registration plate. -- The department may
- 14 reissue a registration plate upon request by a registrant when
- 15 it is determined by an authorized representative of the
- 16 department or law enforcement that the registration plate is
- 17 illegible from a reasonable distance. The department may select
- 18 the style of the reissued registration plate and, except in the

- 1 case of personal registration plates issued under section 1341
- 2 (relating to special registration plates [generally]), the
- 3 registration plate number.
- 4 * * *
- 5 § 1341. Special registration plates [generally].
- 6 (a) General rule. -- Upon request by the applicant, the
- 7 department may issue registration plates consisting of any
- 8 combination of numbers, letters or numbers and letters. [These
- 9 special plates may be issued for special groups or for special
- 10 purposes and bear an appropriate designation. Special groups may
- 11 charge a fee for authorization to request a registration plate
- 12 bearing the name of the group.] They shall have the same force
- 13 and effect as regular registration plates. The department may
- 14 refuse any combination of letters and numbers for cause and
- 15 shall adopt reasonable rules and regulations for the issuance of
- 16 the plates and for carrying out the provisions of this section.
- 17 The applicant shall comply with all laws and regulations
- 18 pertaining to registration including the payment of any
- 19 additional fees.
- 20 (b) Personal registration plates. -- Upon request by the
- 21 applicant, the department is authorized to issue personal
- 22 <u>registration plates.</u> The department is authorized to reissue a
- 23 combination of numbers or letters for a personal plate if the
- 24 department records reveal that no activity, such as renewal or
- 25 transfer of the personal registration plate, has occurred for a
- 26 period of five or more consecutive years and provided that the
- 27 personal registration plate was never reported as lost or
- 28 stolen. Whenever the department reissues an inactive personal
- 29 plate, the department may purge its records of all references to
- 30 the previous owners of that personal plate. The department

- 1 shall, however, note upon its records the reissuance of the
- 2 personal plate and to whom the plate was issued. [The special] \underline{A}
- 3 <u>personal</u> registration plate may be used only on a passenger car
- 4 [or], motorcycle, truck with a registered gross weight of not
- 5 more than [10,000] <u>14,000</u> pounds, trailer or motor home.
- 6 (c) Organization registration plates. -- Upon request by the
- 7 applicant, the department is authorized to issue organization
- 8 registration plates. Organization registration plates may be
- 9 issued for special groups or for special purposes and bear an
- 10 appropriate designation. Special groups may charge a fee for
- 11 <u>authorization to request a registration plate bearing the name</u>
- 12 of the group. If the vehicle is licensed to a business that is
- 13 not a member of the special group, the department shall issue
- 14 the plate as long as the business owner or officer making
- 15 application is a member of that group. An organization
- 16 registration plate may be used only on a passenger car or truck
- 17 with a registered gross weight of not more than 14,000 pounds or
- 18 <u>a motor home</u>.
- 19 Section 2. Title 75 is amended by adding sections to read:
- 20 § 1341.1 Personal organization registration plates.
- 21 (a) General rule. -- The department may, upon application of
- 22 any person and upon payment of the additional fee under this
- 23 section, issue a personal organization registration plate to
- 24 applicants for special registration plates authorized in this
- 25 chapter.
- 26 (b) Additional fee.--
- 27 (1) The department shall collect an additional fee of up-<--
- 28 to \$300 for any personal special registration plate or \$100 <--
- 29 FOR personal organization registration plates issued under
- 30 subsection (a).

- 1 (2) For any personal plate issued under sections 1338
- 2 (relating to person with disability plate and placard) and
- 3 1342 (relating to veteran plates and placard), the department
- 4 <u>shall collect only an additional fee of \$50.</u>
- 5 § 1352.1. Appalachian Trail organization registration plates.
- 6 (A) GENERAL RULE. -- The department, in consultation with the <--
- 7 Appalachian Trail Conservancy, shall design a special
- 8 Appalachian Trail organization registration plate. The plate, at
- 9 <u>a minimum, shall contain the image of a hiker and the</u>
- 10 Appalachian Trail Conservancy logo and distinctive coloring.
- 11 Upon application of any person, accompanied by the appropriate <--
- 12 fee, the appalachian trail conservancy may charge a fee for the <--
- 13 <u>AUTHORIZATION TO REQUEST THE REGISTRATION PLATE. UPON REQUEST BY</u>
- 14 THE APPLICANT, the department shall issue the plate for a
- 15 passenger car or truck with a registered gross weight of not
- 16 more than 14,000 pounds or a motor home. THE FEE PROVIDED UNDER <--
- 17 SECTION 1931 (RELATING TO SPECIAL REGISTRATION PLATES) SHALL
- 18 APPLY.
- 19 (B) PROCEEDS.--IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT <--
- 20 PROCEEDS RECEIVED BY THE APPALACHIAN TRAIL CONSERVANCY UNDER
- 21 THIS SECTION ARE TO BE USED EXCLUSIVELY FOR TRAIL MAINTENANCE
- 22 AND IMPROVEMENT.
- 23 Section 3. Sections 1786(h)(2) and 1931 of Title 75 are
- 24 amended to read:
- 25 § 1786. Required financial responsibility.
- 26 * * *
- 27 (h) Reinstatement of voluntarily surrendered registration
- 28 plate and card.--
- 29 * * *
- 30 (2) Any registration plate issued under sections 1340

- 1 (relating to antique and classic plates) and 1341 (relating
- 2 to [personal plate] <u>special registration plates</u>) shall be
- 3 returned by the department to the owner of the motor vehicle
- 4 upon receipt of proof of financial responsibility.
- 5 * * *
- 6 § 1931. [Personal] <u>Special</u> registration plates.
- 7 The fee for issuance of a [personal] special registration
- 8 plate shall be \$20 which shall be in addition to the annual
- 9 registration fee. Only one payment of the issuance fee shall be
- 10 charged for each [personal] special registration issued or
- 11 replaced.
- 12 Section 4. This act shall take effect in 120 days.
