(a) Authorization. -- The Pennsylvania Board of Law Examiners 14 15 may require that persons applying for admission to the bar and 16 the practice of law in this Commonwealth submit: 17 (1) A Federal criminal history record check through the

Federal Bureau of Investigation.

- 2 <u>Pennsylvania State Police.</u>
- 3 (b) Fingerprints required. -- If an applicant as required
- 4 <u>under subsection (a) submits fingerprints to the Pennsylvania</u>
- 5 State Police for the purpose of obtaining criminal history
- 6 record checks, the Pennsylvania State Police, or its authorized
- 7 agent, shall submit the fingerprints to the Federal Bureau of
- 8 <u>Investigation for the purpose of verifying the identity of the</u>
- 9 applicant and obtaining a current record of any criminal arrests
- 10 and convictions.
- 11 (c) Use of information. -- Any information relating to an
- 12 <u>applicant and obtained under this section by the Pennsylvania</u>
- 13 Board of Law Examiners may be interpreted and used by the
- 14 Pennsylvania Board of Law Examiners to determine the applicant's
- 15 character, fitness and suitability for admission to the bar and
- 16 the practice of law in this Commonwealth.
- 17 (d) Inapplicability. -- The provisions of 18 Pa.C.S. § 9121(b)
- 18 (2) (relating to general regulations) shall not apply if a
- 19 request for a criminal history record check is submitted
- 20 pursuant to this section.
- 21 Section 2. This act shall take effect in 60 days.
