AN ACT

Authorizing the Department of General Services, with the

approval of the Department of Military and Veterans Affairs 2 3

and the Governor, to grant and convey to Uptown Entertainment

Alliance, or its successors or assigns, certain lands, 4

buildings and improvements situate in the Borough of West 5

Chester, Chester County. 6

- 7 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 8
- Section 1. Conveyance in West Chester Borough, Chester County.
- 10 Authorization. -- The Department of General Services, with
- 11 the approval of the Department of Military and Veterans Affairs
- 12 and the Governor, is hereby authorized on behalf of the
- 13 Commonwealth of Pennsylvania to grant and convey to Uptown
- 14 Entertainment Alliance, or its successors or assigns, certain
- 15 lands, buildings and improvements situate in the Borough of West
- Chester, Chester County, for \$760,000 and under terms and 16
- 17 conditions to be established in an Agreement of Sale.
- 18 Property description. -- The property to be conveyed under
- 19 this section consists of approximately 0.58-acres of land and
- improvements located thereon, bounded and more particularly 20

- 1 bounded and described as follows:
- 2 ALL THAT CERTAIN LOT, PIECE OR PARCEL OF LAND situate in the
- 3 West Ward of the Borough of West Chester, Chester County,
- 4 bounded and described as follows, to wit:
- 5 BEGINNING at the intersection of the street lines at the
- 6 Southwest corner of High and Washington Streets, thence
- 7 extending Westwardly along the South street line of Washington
- 8 Street a distance of 147 feet 6 inches to the Easterly side of a
- 9 20 foot wide public alley, thence Southward at right angles to
- 10 Washington Street and along the Easterly line of the aforesaid
- 11 alley (known as School Alley) a distance of 175 feet 5 inches to
- 12 the North line of another 20 foot wide public alley (known as
- 13 Patton Alley), thence Eastward along the North line of the last
- 14 mentioned public alley a distance of 147 feet 9 inches to the
- 15 West street line of High Street, thence Northward along the West
- 16 street line of said High Street a distance of 171 feet 1 inch to
- 17 the first mentioned point and place of BEGINNING.
- 18 CONTAINING 0.58-acres more or less.
- 19 BEING Tax Parcel No. 01050221000E; 1-5-221E.
- 20 BEING the same premises conveyed by Linda A. Painter to the
- 21 Commonwealth of Pennsylvania, by deed, dated December 6, 1915
- 22 and recorded in Chester County in Deed Book R14, Volume 339,
- 23 Page 282.
- 24 (c) Easements. -- The conveyance shall be made under and
- 25 subject to all lawful and enforceable easements, servitudes and
- 26 rights of others, including but not confined to streets,
- 27 roadways and rights of any telephone, telegraph, water,
- 28 electric, gas or pipeline companies, as well as under and
- 29 subject to any lawful and enforceable estates or tenancies
- 30 vested in third persons appearing of record, for any portion of

- 1 the land or improvements erected thereon.
- 2 (d) Restriction. -- Any conveyance authorized under this act
- 3 shall be made under and subject to the condition, which shall be
- 4 contained in the deed of conveyance, that no portion of the
- 5 property conveyed shall be used as a licensed facility, as
- 6 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any
- 7 other similar type of facility authorized under State law. The
- 8 condition shall be a covenant running with the land and shall be
- 9 binding upon the Grantee, its successors and assigns. Should the
- 10 Grantee, its successors or assigns, permit any portion of the
- 11 property authorized to be conveyed in this act to be used in
- 12 violation of this subsection, the title shall immediately revert
- 13 to and revest in the Grantor.
- 14 (e) Oil, gas and mineral rights. -- The oil, gas and mineral
- 15 rights shall be retained by the Department of General Services,
- 16 on behalf of the Commonwealth of Pennsylvania, and may be leased
- 17 by the Department of General Services in accordance with the
- 18 authority granted in the act of October 8, 2012 (P.L.1194,
- 19 No.147), known as the Indigenous Mineral Resources Development
- 20 Act.
- 21 (f) Conditions. -- The Secretary of General Services may
- 22 impose any covenants, conditions or restrictions on the property
- 23 at settlement as determined to be in the best interests of this
- 24 Commonwealth.
- 25 (q) Deed of conveyance. -- The deed of conveyance shall be by
- 26 Special Warranty Deed and shall be executed by the Secretary of
- 27 General Services in the name of the Commonwealth of
- 28 Pennsylvania.
- 29 (h) Costs and fees. -- Costs and fees incidental to this
- 30 conveyance shall be borne by the Grantee.

- 1 (i) Deposit of proceeds. -- The proceeds from the sale shall
- 2 be deposited in the State Treasury Armory Fund.
- 3 (j) Alternative disposition. -- In the event that this
- 4 conveyance is not executed within three years of the effective
- 5 date of this section, the property may be disposed of through a
- 6 competitive bid process.
- 7 Section 2. Effective date.
- 8 This act shall take effect immediately.
