AN ACT

Reenacting and amending the act of April 12, 2006 (P.L.67, No.22), entitled "An act providing a bonus to Pennsylvanians 2 who are United States Merchant Marine veterans who served 3 during World War II; imposing certain duties on the Adjutant General; providing penalties; and making an appropriation." 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. The title and preamble of the act of April 12, 2006 (P.L.67, No.22), known as the Merchant Marine World War II 10 Veterans Bonus Act, are reenacted to read: 11 AN ACT Providing a bonus to Pennsylvanians who are United States 12 13 Merchant Marine veterans who served during World War II; 14 imposing certain duties on the Adjutant General; providing 15 penalties; and making an appropriation. 16 The General Assembly finds and declares as follows: The United States Merchant Marine served with honor 17 18 and at great risk during World War II.

- 1 (2) Individuals serving in the United States Merchant
- 2 Marine during World War II had a greater casualty rate than
- 3 any branch of the armed forces.
- 4 (3) Dwight D. Eisenhower, in his capacity as General and
- 5 Supreme Commander Allied Expeditionary Force in Europe,
- 6 observed in the midst of the war that "when victory is
- finally ours, there is no organization that will share its
- 8 credit more deservedly than the Merchant Marine."
- 9 (4) Pennsylvania has recognized the honored service of
- 10 United States Merchant Marine veterans of World War II as
- 11 military service for purposes ranging from pension credit to
- 12 the National World War II Memorial christened in 2001.
- 13 (5) United States Merchant Marine veterans deserve to be
- 14 recognized and thanked for their service by the Commonwealth,
- 15 even at this late date.
- 16 Section 2. Section 1 of the act is reenacted to read:
- 17 Section 1. Short title.
- 18 This act shall be known and may be cited as the Merchant
- 19 Marine World War II Veterans Bonus Act.
- 20 Section 3. Section 2 of the act is reenacted and amended to
- 21 read:
- 22 Section 2. Definitions.
- 23 The following words and phrases when used in this act shall
- 24 have the meanings given to them in this section unless the
- 25 context clearly indicates otherwise:
- 26 "Adjutant General." The Adjutant General of the
- 27 Commonwealth.
- 28 "Fund." The United States Merchant Marine World War II
- 29 Veterans' Bonus Fund established in section 9.
- 30 "Legal resident of this Commonwealth." An individual who is

- 1 a resident of this Commonwealth on the effective date of this
- 2 act. If there is a question of residency, the issue shall be
- 3 determined by the Adjutant General based on standard and
- 4 uniformly applied criteria.
- 5 "Merchant Marine." The United States Merchant Marine.
- 6 "Merchant Marine veteran who served during World War II."
- 7 (1) The term includes any individual who served active
- 8 duty, including training, in the United States Merchant
- 9 Marine between December 7, 1941, and August 15, 1945,
- including training with the United States Merchant Marine or
- 11 the United States Maritime Service.
- 12 (2) The term does not include:
- 13 (i) any individual at any time during such period,
- or thereafter, separated from the oceangoing United
- 15 States Merchant Marine under other than honorable
- 16 conditions;
- 17 (ii) any individual who renounced his United States
- 18 citizenship during such period; or
- 19 (iii) any individual who, during such period,
- refused on conscientious, political, religious or other
- 21 grounds to be subject to military discipline.
- 22 Section 4. Section 3 of the act is reenacted to read:
- 23 Section 3. Bonus.
- A bonus of \$500 shall be payable under this act to any United
- 25 States Merchant Marine veteran who served during World War II
- 26 and is a legal resident of this Commonwealth.
- 27 Section 5. Section 4 of the act is reenacted and amended to
- 28 read:
- 29 Section 4. Application for bonus.
- 30 (a) General rule. -- Application for compensation shall be

- 1 made to the Adjutant General on such forms and in such manner as
- 2 the Adjutant General prescribes. A federally issued DD-214 form
- 3 evidencing honorable discharge from service in the United States
- 4 Merchant Marine for a period including any portion of the period
- 5 from December 7, 1941, through August 15, 1945, shall be deemed
- 6 sufficient evidence of qualifying service. A release from active
- 7 duty form issued by the United States Maritime Service between
- 8 December 7, 1941, and August 15, 1945, shall be deemed
- 9 <u>sufficient evidence of qualifying training time in the United</u>
- 10 States Merchant Marines. The Adjutant General shall assist
- 11 applicants in obtaining copies of Federal DD-214 forms or
- 12 <u>release from active duty forms</u> should the applicant desire
- 13 assistance.
- 14 (b) Personal application; exception. -- An application shall
- 15 be made personally by the United States Merchant Marine veteran
- 16 who served during World War II and is a legal resident of this
- 17 Commonwealth. However, in the event that health or incompetency
- 18 prevents a personal application, then such representative of the
- 19 veteran as the Adjutant General shall prescribe shall serve as
- 20 attorney-in-fact for purposes of applying for and receiving the
- 21 bonus. An application made by a representative other than one
- 22 authorized by the Adjutant General shall be void.
- 23 (c) Acceptance and consideration of applications. -- The
- 24 Adjutant General shall not accept or consider any application
- 25 filed with the Adjutant General after December 31, [2006] 2014.
- 26 The decisions of the Adjutant General in consideration of
- 27 applications shall be final and not subject to review by any
- 28 court or by any other officer[.], except a veteran whose
- 29 application was denied because the veteran's active duty with
- 30 the United States Merchant Marine was in training with the

- 1 <u>United States Maritime Service between December 7, 1941, and</u>
- 2 August 15, 1945, may reapply for compensation.
- 3 Section 6. Sections 5, 6, 7 and 8 of the act are reenacted
- 4 to read:
- 5 Section 5. Exemption from attachment.
- 6 No sum payable under this act to a United States Merchant
- 7 Marine veteran or any other person under this act shall be
- 8 subject to attachment, levy or seizure under any legal or
- 9 equitable process and shall be exempt from all State taxation.
- 10 No right to compensation under this act shall be assignable or
- 11 serve as a security for any loan. Any assignment or loan made in
- 12 violation of this section shall be held void.
- 13 Section 6. Penalty for fees for assisting with bonus
- 14 application.
- 15 Any person who charges or collects or attempts to charge or
- 16 collect, either directly or indirectly, any fee or other
- 17 compensation for assisting, in any manner, a veteran in
- 18 obtaining any of the benefits to which the veteran is entitled
- 19 under this act commits a misdemeanor and, upon conviction
- 20 thereof, shall be subject to a fine of not more than \$2,500 or
- 21 to imprisonment for not more than one year, or both, for each
- 22 violation.
- 23 Section 7. Digest and explanation of act.
- 24 The Adjutant General shall, as soon as practicable after the
- 25 effective date of this act, prepare and publish a pamphlet or
- 26 pamphlets containing a digest and explanation of this act,
- 27 accompanied by such statements as the Adjutant General believes
- 28 may be of assistance to the United States Merchant Marine
- 29 veterans who served during World War II in filing their
- 30 applications, and shall from time to time prepare and publish

- 1 additional or supplementary information as may be found
- 2 necessary. The pamphlet or pamphlets shall be distributed in
- 3 such manner as the Adjutant General may determine to be most
- 4 effective to inform United States Merchant Marine veterans of
- 5 their rights under this act. The Adjutant General shall enlist,
- 6 as far as possible, the services of United States Merchant
- 7 Marine veteran organizations in this Commonwealth in the
- 8 dissemination of such information.
- 9 Section 8. Administration of act.
- 10 (a) General administration. -- The Adjutant General shall
- 11 administer this act and shall prepare and distribute
- 12 applications, investigate all claims and applications filed with
- 13 the Adjutant General and, if satisfied of the proof of such
- 14 claim or application, approve the application and direct payment
- 15 thereof. The Adjutant General shall make any regulation
- 16 necessary to administer this act.
- 17 (b) Records. -- The books, papers and records, together with
- 18 the filing cases and equipment procured and used in the
- 19 administration of this act, shall become a part of the permanent
- 20 records of the office of Adjutant General.
- 21 (c) Oaths and affirmations.--Employees of the Department of
- 22 Military and Veterans Affairs, whose specific duty is to aid and
- 23 assist veterans and their widows, children and dependents in the
- 24 prosecution of claims before the Department of Veterans Affairs
- 25 or other branch of the Federal Government, are hereby authorized
- 26 and empowered to administer oaths and affirmations in all
- 27 matters pertaining to and concerning such claims.
- 28 Section 7. Section 9 of the act is reenacted and amended to
- 29 read:
- 30 Section 9. United States Merchant Marine World War II Veterans'

- 1 Bonus Fund.
- 2 (a) Establishment. -- The United States Merchant Marine World
- 3 War II Veterans' Fund is hereby established as a restricted
- 4 receipt account within the General Fund. The fund shall be
- 5 administered by the State Treasurer.
- 6 (b) Source of moneys. -- Moneys to be deposited in the fund
- 7 shall be appropriated from the General Fund by the General
- 8 Assembly.
- 9 (c) Lapsing of funds. -- Any moneys appropriated to the fund
- 10 remaining unexpended or unencumbered on June 30, [2007] 2015,
- 11 shall lapse into the General Fund.
- 12 Section 8. Section 10 of the act is reenacted to read:
- 13 Section 10. Payment.
- 14 The compensation payable under this act shall be paid by the
- 15 State Treasurer from the United States Merchant Marine World War
- 16 II Veterans' Bonus Fund.
- 17 Section 9. Section 11 of the act is reenacted and amended to
- 18 read:
- 19 Section 11. Expiration.
- 20 This act shall expire on June 30, [2007] <u>2015</u>.
- 21 Section 10. Section 12 of the act is reenacted to read:
- 22 Section 12. Effective date.
- This act shall take effect immediately.
