Runyan Memorial Bridge; DESIGNATING THE TRAFFIC CIRCLE ON STATE 4 <---ROUTE 116 AT HANOVER ROAD AND ROTH'S CHURCH ROAD IN SPRING 5 GROVE, YORK COUNTY, AS THE OFFICER DAVID D. TOME MEMORIAL 6 CIRCLE; DESIGNATING A BRIDGE ON STATE ROUTE 116 IN SPRING 7 8 GROVE BOROUGH, YORK COUNTY, AS THE CAMERON J. STAMBAUGH MEMORIAL BRIDGE; DESIGNATING A BRIDGE ON THAT PORTION OF 9 STATE ROUTE 4002 BETWEEN INTERMEDIATE AVENUE AND MUNICIPAL 10 DRIVE IN DOVER BOROUGH, YORK COUNTY, AS THE ZACHARY R. 11 CLOUSER MEMORIAL BRIDGE; AND DESIGNATING THE BRIDGE ON STATE 12 13 ROUTE 74 BETWEEN DRAWBAUGH AVENUE AND MILL ALLEY, DOVER BOROUGH, YORK COUNTY, AS THE SERGEANT BRETT E. WALDEN 14 MEMORIAL BRIDGE. 15 The General Assembly of the Commonwealth of Pennsylvania 16 17 hereby enacts as follows:
- 18 Section 1. Corporal Luke S. Runyan Memorial Bridge.
- 19 (a) Findings.--The General Assembly finds and declares as
- 20 follows:

21 (1) Corporal Luke S. Runyan, age 21, formerly of Spring

Grove Borough, York County, was killed in combat on February
 17, 2008, in Diyala Province, Iraq while serving as a squad
 leader with the United States Army.

4 (2) Corporal Runyan was killed during a dismounted
5 engagement with insurgents while coming to the aid of another
6 Army unit.

7 (3) Corporal Runyan was born on June 17, 1986, in York.
8 He was a 2004 graduate of Spring Grove Area High School.
9 After graduation, Luke S. Runyan immediately enlisted in the
10 United States Army.

11 (4) Corporal Runyan is survived by his wife, Courtney,12 and daughter, Brynn, who reside in Renton, Washington.

(b) Designation.--The bridge located on State Route 3072,
Hanover Road, near its intersection with State Route 3092, Lake
Road, in Spring Grove Borough, York County is hereby designated
the Corporal Luke S. Runyan Memorial Bridge.

17 (c) Signs.--The Department of Transportation shall erect and 18 maintain appropriate signs displaying the name of the bridge to 19 traffic in both directions on the bridge.

COUNTY REGIONAL POLICE DEPARTMENT. HE WAS 31 YEARS OF AGE.

26 (2) OFFICER TOME LEFT BEHIND HIS WIFE OF SEVEN YEARS,
27 DODY, AND TWO CHILDREN, ELIJAH AND JOSLYN TOME.

(3) OFFICER TOME WAS A NATIVE OF YORK AND A 1996
GRADUATE OF SPRING GROVE AREA HIGH SCHOOL. HE GRADUATED IN
2003 FROM HARRISBURG AREA COMMUNITY COLLEGE'S 83RD POLICE

2 (4) OFFICER TOME SERVED FIVE YEARS WITH THE NORTHERN
3 YORK COUNTY REGIONAL POLICE DEPARTMENT.

4 (B) DESIGNATION.--THE TRAFFIC CIRCLE LOCATED ON STATE ROUTE
5 116 AT HANOVER ROAD AND ROTH'S CHURCH ROAD IN SPRING GROVE, YORK
6 COUNTY, IS HEREBY DESIGNATED THE OFFICER DAVID D. TOME MEMORIAL
7 CIRCLE.

8 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
9 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE TRAFFIC
10 CIRCLE TO APPROACHING TRAFFIC.

11 SECTION 3. CAMERON J. STAMBAUGH MEMORIAL BRIDGE.

12 (A) FINDINGS.--

13 (1) UNITED STATES ARMY SPECIALIST CAMERON J. STAMBAUGH,
14 AGE 20, WAS KILLED IN ACTION WHILE SERVING HIS COUNTRY IN
15 AFGHANISTAN ON JULY 8, 2012.

16 (2) BORN MAY 28, 1992, IN YORK, STAMBAUGH WAS A 2010
17 GRADUATE OF SPRING GROVE AREA HIGH SCHOOL.

18 (3) STAMBAUGH SERVED IN THE ARMY'S 978TH MILITARY POLICE19 COMPANY OF FORT BLISS AND WAS STATIONED IN AFGHANISTAN.

20 (4) HE IS SURVIVED BY HIS PARENTS AND BY HIS WIFE,21 JACKIE.

(B) DESIGNATION.--THE BRIDGE LOCATED ON STATE ROUTE 116 IN
SPRING GROVE BOROUGH, YORK COUNTY, IS HEREBY DESIGNATED THE
CAMERON J. STAMBAUGH MEMORIAL BRIDGE.

(C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.

30 (1) SPECIALIST ZACHARY RYAN CLOUSER, AGE 19, WAS KILLED 20130HB1431PN2515 - 3 - IN ACTION ON JULY 18, 2007, IN IRAQ WHILE SERVING WITH THE
 UNITED STATES ARMY IN SUPPORT OF OPERATION IRAQI FREEDOM.

3 (2) SPECIALIST CLOUSER GRADUATED FROM DOVER AREA HIGH
4 SCHOOL IN 2005 AND ENLISTED IN THE UNITED STATES ARMY ON
5 SEPTEMBER 27, 2005.

6 (3) AFTER COMPLETING TRAINING IN FORT BENNING, GEORGIA,
7 SPECIALIST CLOUSER WAS ASSIGNED IN FEBRUARY OF 2006 TO 1ST
8 PLATOON, "APACHE" COMPANY, 1ST BATTALION, 26TH INFANTRY "BLUE
9 SPADERS" IN SCHWEINFURT, GERMANY, AS AN M2A2 BRADLEY FIGHTING
10 VEHICLE DRIVER.

(4) SPECIALIST CLOUSER DEPLOYED TO IRAQ ON AUGUST 6,
2006, AND PARTICIPATED IN NUMEROUS COMBAT PATROLS IN
NORTHEAST BAGHDAD AND ADHAMIYAH, IRAQ. HE SERVED AS BOTH HIS
PLATOON SERGEANT'S M1151 UP-ARMOR HMMWV MACHINE GUNNER AND
M2A2 BRADLEY FIGHTING VEHICLE GUNNER.

16 (5) SPECIALIST CLOUSER WAS POSTHUMOUSLY AWARDED THE
17 BRONZE STAR MEDAL, THE PURPLE HEART AND THE COMBAT
18 INFANTRYMAN BADGE. HIS OTHER DECORATIONS INCLUDE THE ARMY
19 COMMENDATION MEDAL, NATIONAL DEFENSE SERVICE MEDAL, IRAQ
20 CAMPAIGN MEDAL, GLOBAL WAR ON TERRORISM SERVICE MEDAL, ARMY
21 SERVICE RIBBON AND OVERSEAS SERVICE RIBBON WITH NUMERAL 2.

22 (6) BORN AUGUST 6, 1987, IN YORK, SPECIALIST CLOUSER WAS
23 THE SON OF KEVIN CLOUSER AND STEPMOTHER GINGER ASPER CLOUSER
24 OF WEST YORK, AND DEBRA ETHERIDGE AND STEPFATHER RONALD
25 ETHERIDGE OF DOVER.

 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.

3 SECTION 5. SERGEANT BRETT E. WALDEN MEMORIAL BRIDGE.

4 (A) FINDINGS.--

5 (1) SERGEANT FIRST CLASS BRETT E. WALDEN, AGE 40, WAS
6 KILLED IN ACTION ON AUGUST 5, 2005, IN RABIAH, IRAQ, WHILE
7 SERVING THIS NATION IN THE UNITED STATES ARMY.

8 (2) SERGEANT WALDEN, WHOSE HOME WAS IN DOVER BOROUGH,
9 YORK COUNTY, WAS AN AIRBORNE RANGER INSTRUCTOR WITH THE 5TH
10 SPECIAL FORCES GROUP BASED IN FORT CAMPBELL, KENTUCKY.

(3) SERGEANT WALDEN WAS A DECORATED SOLDIER, HAVING
ATTAINED THE EXPERT INFANTRY BADGE, THE COMBAT INFANTRY
BADGE, THE GLOBAL WAR ON TERRORISM MEDAL, THE GLOBAL WAR ON
TERRORISM EXPEDITIONARY MEDAL, THE IRAQI AND AFGHANISTAN
CAMPAIGN MEDAL, TWO BRONZE STAR MEDALS, THE MERITORIOUS
SERVICE MEDAL AND THE PURPLE HEART.

17 (4) HE IS SURVIVED BY HIS WIFE, AUTUMN, AND THEIR18 DAUGHTER, ALEXANDRA.

(B) DESIGNATION.--THE BRIDGE LOCATED ON STATE ROUTE 74
BETWEEN DRAWBAUGH AVENUE AND MILL ALLEY, DOVER BOROUGH, YORK
COUNTY, IS HEREBY DESIGNATED AS THE SERGEANT BRETT E. WALDEN
MEMORIAL BRIDGE.

(C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.
