AN ACT

- Authorizing the Department of General Services, with the 1 approval of the Governor and the Department of 2 Transportation, to grant and convey, at a price to be 3 determined through a competitive bid process, certain lands, buildings and improvements situate in the Borough of 5 Carlisle, Cumberland County; authorizing the Department of 6 General Services, with the approval of the Governor and the 7 Pennsylvania Historical and Museum Commission, to grant and 8 9 convey to the Bear Valley Franklin County Pennsylvania Joint Authority, or its assigns, two permanent utility and access 10 easements from lands of the Commonwealth of Pennsylvania at 11 the Ft. Loudon Historical Site situate in Peters Township, 12 Franklin County, for purpose of groundwater withdrawal; 13 authorizing the Department of General Services, with the 14 approval of the Governor, to accept a conveyance of real 15 property from the County of Lackawanna Transit System 16 Authority, certain lands situate in the City of Scranton, 17 Lackawanna County; and authorizing the Department of General 18 19 Services, with the approval of the Governor, to grant and convey, at a price to be determined through a public 20 solicitation for proposals, certain lands, buildings and 21 improvements situate in the City of Allentown and the City of 22 Bethlehem, Lehigh County. 23 24 The General Assembly of the Commonwealth of Pennsylvania 25 hereby enacts as follows: 26 Section 1. Conveyance in Borough of Carlisle, Cumberland 27 County.
- 28 (a) Authorization. -- The Department of General Services, with

- 1 the approval of the Governor and the Department of
- 2 Transportation, is hereby authorized on behalf of the
- 3 Commonwealth of Pennsylvania to grant and convey, at a price to
- 4 be determined through a competitive bidding process, the
- 5 following tract of land together with any buildings, structures
- 6 or improvements thereon, situate in the Borough of Carlisle,
- 7 Cumberland County.
- 8 (b) Description. -- The property to be conveyed pursuant to
- 9 subsection (a) consists of a tract of land totaling
- 10 approximately 2.3848-acres, including any and all improvements
- 11 located thereon, more particularly described as follows:
- 12 BEGINNING at an iron pin, sunk in the ground, on the south
- 13 side of West North Street, two hundred feet (200) from the

- 28 CONTAINING 2.3848-acres more or less.
- 29 BEING the same premises conveyed to the Commonwealth of
- 30 Pennsylvania from A. Lee Edwards and Margaret B. Edwards, his

- 1 wife, by deed, dated December 27, 1934, and recorded January 4,
- 2 1935, in the Recorder of Deeds for Cumberland County,
- 3 Pennsylvania, in Deed Book 0011M, Page 00431.
- 4 (C) OIL, GAS AND MINERAL RIGHTS.--THE OIL, GAS AND MINERAL <--
- 5 RIGHTS SHALL BE RETAINED BY THE DEPARTMENT OF GENERAL SERVICES,
- 6 ON BEHALF OF THE COMMONWEALTH OF PENNSYLVANIA, AND MAY BE LEASED
- 7 BY THE DEPARTMENT OF GENERAL SERVICES IN ACCORDANCE WITH THE
- 8 AUTHORITY GRANTED IN THE ACT OF OCTOBER 8, 2012 (P.L.1194,
- 9 NO.147), KNOWN AS THE INDIGENOUS MINERAL RESOURCES DEVELOPMENT
- 10 ACT.
- 11 (c) (D) Easements.--This conveyance shall be made under and <--
- 12 subject to all lawful and enforceable easements, servitudes and
- 13 rights of others, including but not confined to streets,
- 14 roadways and rights of any telephone, telegraph, water,
- 15 electric, gas or pipeline companies, as well as under and
- 16 subject to any lawful and enforceable estates or tenancies
- 17 vested in third persons appearing of record, for any portion of
- 18 the land or improvements erected thereon.
- 19 $\frac{\text{(d)}}{\text{(E)}}$ Deed.--The deed of conveyance shall be executed by <--
- 20 the Secretary of General Services in the name of the
- 21 Commonwealth of Pennsylvania.
- 22 (e) (F) Deposit of proceeds.--The proceeds from the sale <--
- 23 shall be deposited in the Motor License Fund and shall be
- 24 utilized by the Department of Transportation and the Department
- 25 of General Services to remediate and demolish the "old"
- 26 Materials Testing Laboratory located in the City of Harrisburg,
- 27 Dauphin County. Any funds remaining after the remediation and
- 28 demolition of that structure shall be available to the
- 29 Department of Transportation for any other duly authorized
- 30 purpose.

1 (G) GAMING RESTRICTION. -- THE CONVEYANCE AUTHORIZED BY THIS

- 2 SECTION SHALL BE MADE UNDER AND SUBJECT TO THE CONDITION, WHICH
- 3 SHALL BE CONTAINED IN THE DEED OF CONVEYANCE, THAT NO PORTION OF
- 4 THE PROPERTY CONVEYED SHALL BE USED AS A LICENSED FACILITY, AS
- 5 DEFINED IN 4 PA.C.S. § 1103 (RELATING TO DEFINITIONS), OR ANY
- 6 OTHER SIMILAR TYPE FACILITY AUTHORIZED UNDER STATE LAW. THE
- 7 CONDITION SHALL BE A COVENANT RUNNING WITH THE LAND AND SHALL BE
- 8 BINDING UPON THE GRANTEE, ITS SUCCESSORS AND ASSIGNS. SHOULD THE

- 15 the approval of the Governor and the Pennsylvania Historical and
- 16 Museum Commission, is hereby authorized on behalf of the
- 17 Commonwealth of Pennsylvania to grant and convey to the Bear
- 18 Valley Franklin County Pennsylvania Joint Authority, or its
- 19 assigns, two permanent utility and access easements from lands
- 20 of the Commonwealth of Pennsylvania at the Ft. Loudon Historical
- 21 Site situate in Peters Township, Franklin County for purposes of
- 22 groundwater withdrawal for a one-time payment of \$19,500 and
- 23 under terms and conditions to be established in an easement
- 24 agreement.

- 11 (c) Agreement. -- The easement agreement shall be executed by
- 12 the Secretary of General Services in the name of the
- 13 Commonwealth of Pennsylvania.
- 14 (d) Costs and fees.--Costs and fees incidental to this
- 15 conveyance of the two utility easements shall be borne by the
- 16 Grantee.
- 17 (e) Expiration.--In the event that the parties have not
- 18 entered into an easement agreement within one year of the
- 19 effective date of this section, the authorization contained in
- 20 subsection (a) shall expire.
- 21 Section 3. Conveyance in City of Scranton, Lackawanna County.
- 22 (a) Authorization. -- In order to effectuate Section 7 of the
- 23 act of July 7, 2011 (P.L.225, No.43), entitled "An act
- 24 authorizing Venango County to convey a right-of-way over certain
- 25 Project 70 lands in Oakland Township, Venango County, free of
- 26 restrictions imposed by the Project 70 Land Acquisition and
- 27 Borrowing Act; authorizing the Department of General Services,
- 28 with the approval of the Department of Conservation and Natural
- 29 Resources and the Governor, to grant and convey to East Norriton
- 30 Township certain lands situate in East Norriton Township,

- 1 Montgomery County, in exchange for East Norriton Township's
- 2 granting and conveying certain lands to the Commonwealth of
- 3 Pennsylvania to be added to the existing lands of the Norristown
- 4 Farm Park; authorizing the Department of General Services, with
- 5 the approval of the Department of Conservation and Natural
- 6 Resources and the Governor, to remove the deed restrictions on a
