Donatucci Memorial Bridge; < AND DESIGNATING A PORTION OF STATE ROUTE 23 IN WEST HEMPFIELD TOWNSHIP, LANCASTER COUNTY, AS THE SFC BRENT ADAMS MEMORIAL ROAD.
7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. Honorable Robert C. Donatucci Memorial Bridge.
10	(a) Findings
11	(1) Robert "Bobby" Donatucci was a Democratic member of
12	the Pennsylvania House of Representatives, representing the
13	185th Legislative District from 1980 until 2010. The 185th

District includes the 26th Ward in South Philadelphia, half of the 40th Ward in Southwest Philadelphia and three communities in Delaware County: Darby Township, Darby Borough and Colwyn Borough.

5 (2) A native of Philadelphia, Representative Donatucci 6 graduated from Bishop Neuman High School in 1970 and 7 from Temple University in 1974 where he majored in political 8 science.

9 (3) He was first elected to the Pennsylvania House of 10 Representatives in a special election on March 11, 1980.

(4) Representative Donatucci served as chair of the House Liquor Control Committee from 1993 until his passing. As chairman of the Liquor Control Committee, he was charged with overseeing the State Store system that dated to the end of Prohibition and worked tirelessly on the prevention of underage drinking.

17 (5) Representative Donatucci was well respected in his18 community and had a passion for classic cars.

19 (6) Sadly, on November 9, 2010, Representative Robert20 Donatucci passed away suddenly.

(7) He is survived by his wife, Maria; two children,
Dierdre and Thomas; mother, Yolanda; brothers, Ronald and
Thomas and sisters, Rita and Maria.

(b) Designation.--The bridge carrying S.R. STATE ROUTE 3019 <--
over the Schuylkill River in the City of Philadelphia,
Philadelphia County, commonly known as the Passyunk Avenue
Bridge, is hereby designated as the Honorable Robert C.

28 Donatucci Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and
 maintain appropriate signs displaying the name of the bridge to

1 traffic in both directions on the bridge.

2 SECTION 2. SFC BRENT ADAMS MEMORIAL ROAD.

3 (A) FINDINGS.--

4 (1) SFC BRENT ADAMS WAS A NATIVE OF WEST HEMPFIELD
5 TOWNSHIP, LANCASTER COUNTY.

6 (2) SFC ADAMS GRADUATED FROM HEMPFIELD HIGH SCHOOL IN
7 1983 AND LATER FROM INDIANA UNIVERSITY OF PENNSYLVANIA.

8 (3) SFC ADAMS SERVED IN THE PENNSYLVANIA ARMY NATIONAL
9 GUARD FOR ALMOST 18 YEARS AND WAS KILLED IN ACTION ON
10 DECEMBER 1, 2005, IN RAMADI, IRAQ.

11 (4) SFC ADAMS WAS AWARDED THE BRONZE STAR AND A PURPLE
12 HEART.

(5) BEFORE HIS DEPLOYMENT TO IRAQ, SFC ADAMS WAS
EMPLOYED BY SPRINT IN PITTSBURGH AND WAS PRESIDENT OF HIS
CHURCH COUNCIL.

16 (6) SFC ADAMS WAS THE BELOVED FATHER OF DANIEL ADAMS,
17 BELOVED SON OF BARBARA AND JOHN BENARD, BELOVED GRANDSON OF
18 K. ARLENE WIMER, BELOVED BROTHER OF MELISSA ADAMS AND BELOVED
19 UNCLE TO ALEXANDRIA, LILLIAN AND MICHAEL NALEVANKO.

(B) DESIGNATION.--STATE ROUTE 23 FROM THE INTERSECTION OF
IVY DRIVE TO THE INTERSECTION OF PROSPECT ROAD IN WEST HEMPFIELD
TOWNSHIP, LANCASTER COUNTY, IS HEREBY DESIGNATED AS THE SFC
BRENT ADAMS MEMORIAL ROAD.

(C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
 MAINTAIN APPROPRIATE SIGNS TO DISPLAY THE NAME OF THE ROAD TO
 TRAFFIC IN BOTH DIRECTIONS.
