AS REPORTED FROM COMMITTEE ON STATE GOVERNMENT, HOUSE OF REPRESENTATIVES, AS AMENDED, JANUARY 14, 2014

## AN ACT

Approving the release of Project 70 restrictions on certain land owned by the Borough of Downingtown, Chester County, in 2 return for the development of public park improvements within 3 Kardon Park within the Borough of Downingtown and East Caln 4 Township, Chester County; and making a related repeal. 5 The General Assembly of the Commonwealth of Pennsylvania 6 7 hereby enacts as follows: Section 1. Release of restrictions in Chester County. 8 (a) Authorization. -- Pursuant to the requirements of section 9 10 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land Acquisition and Borrowing Act, the 11 12 General Assembly approves the release of Project 70 restrictions 13 from the land owned by the Borough of Downingtown, Chester County, which is more particularly described in subsection (c) 14 15 in accordance with the following conditions: 16 The following apply to consideration: 17 (i) Project 70 restrictions removed from the land 18 described in subsection (c) shall be for \$285,000, which is the fair market value of the restrictions as 19

established by a self-contained appraisal report prepared
by a State-certified general appraiser certified under
the act of July 10, 1990 (P.L.404, No.98), known as the
Real Estate Appraisers Certification Act.

- (ii) Any land within the area described in subsection (c) sold by the Borough of Downingtown, without Project 70 restrictions, shall be for an amount equal to or greater than the fair market value of the land as established by a self-contained appraisal report prepared by a State-certified general appraiser certified under the Real Estate Appraisers Certification Act.
- (2) The proceeds of the sale of the land and the release of the Project 70 restrictions shall be deposited into an interest-bearing account established by the Borough of Downingtown and designated solely for the purposes of the conditions under this subsection.
- (3) The money in the interest-bearing account shall be used by the Borough of Downingtown for the sole purpose of improvements to Kardon Park in accordance with a development plan, including, BUT NOT LIMITED TO:

- (i) Construction plans and specifications prepared by a licensed engineer or landscape architect and preapproved in writing by the department.
- 24 (ii) The following improvements for use by the 25 public:
- 26 (A) Trails.
- 27 (B) Pedestrian bridges.
- (C) Parking.
- 29 (D) Docks and boating slips.
- 30 (E) Enhancements to the water quality and

18	department that an area of land matching the metes and bounds
19	description in subsection (d) has been deed restricted for
20	public park use, which (deed restriction) has been recorded
21	by the Borough of Downingtown in the form and substance
22	acceptable to the department. The department and the Borough
23	of Downingtown may mutually agree on adjustments to the metes
24	and bounds of the public park land as long as the public park
25	land is not less than 20.0 acres in size.
26	(b) Use of money FUNDS securing the public park
27	improvements In accordance with the requirements set forth in
28	subsection (a):
29	(1) The money FUNDS, including interest, shall be used <
30	solely to ensure the development of public park improvements

- 1 within Kardon Park constructed or caused to be constructed by
- 2 the Borough of Downingtown in accordance with the plan
- 3 approved by the department. The money FUNDS shall be released <--
- 4 for the development of the Kardon Park following approval of
- 5 the development plan as set forth in subsection (a)(3).
- 6 (2) Any money FUNDS, including interest, remaining five <--
- 7 years after the date the money is FUNDS ARE deposited, unless <--
- 8 extended by the department for a period not to exceed two
- 9 years, shall immediately be paid to the department for
- 10 deposit in the department's General Restricted Revenue Fund
- for the purpose of funding conservation and recreation
- grants. Failure to make the payment shall result in the
- amount of money FUNDS, including interest, constituting a <-
- debt by the Borough of Downingtown to the Commonwealth.
- 15 (c) Land subject to the release from Project 70
- 16 restrictions. -- The land which is subject to the release from
- 17 Project 70 restrictions in accordance with the provisions under
- 18 subsection (a) is as follows:

- 7 Containing .990 acres.
- 8 Total restricted park property contains 20.097 acres, more or
- 9 less.
- 10 (e) Definition.--As used in this section, the term
- 11 "department" means the Department of Conservation and Natural
- 12 Resources of the Commonwealth.
- 13 Section 2. Repeal.
- 14 (a) Declaration of policy. -- The General Assembly declares
- 15 that the repeal under subsection (b) is necessary to effectuate
- 16 section 1.
- 17 (b) Provision. -- Section 6 of the act of October 24, 2012
- 18 (P.L.1293, No.162), entitled "An act authorizing the Department
- 19 of Conservation and Natural Resources to release, upon the
- 20 satisfaction of certain conditions, Project 70 restrictions on
- 21 certain land owned by the West Rockhill Sellersville Joint
- 22 Recreation Authority, Bucks County; authorizing the conveyance
- 23 of an easement and the release of Project 70 restrictions
- 24 imposed on a portion of land owned by the Pennsylvania Fish and
- 25 Boat Commission in Gamble Township, Lycoming County, in return
- 26 for the imposition of Project 70 restrictions on certain land
- 27 being conveyed to the commission in Gamble Township, Lycoming
- 28 County, and other terms and conditions; authorizing the sale and
- 29 transfer of title for Project 70 lands owned by Erie County to
- 30 Springfield Township, Erie County; authorizing Westmoreland

- 1 County to convey and transfer a fee interest in certain Project
- 2 70 land in Unity Township free of Project 70 restrictions in
- 3 return for the imposition of Project 70 restrictions on other
- 4 land in Unity Township to be acquired by Westmoreland County;
- 5 authorizing the Department of General Services, with the
- 6 approval of the Department of Military and Veterans Affairs and
- 7 the Governor, to grant and convey to QRS Realty Corp. certain
- 8 lands and building situate in the City of Erie, Erie County; and
- 9 approving the release of Project 70 restrictions on certain land
- 10 owned by the Borough of Downingtown, Chester County, in return
- 11 for the development of public park improvements within Kardon
- 12 Park within the Borough of Downingtown and East Caln Township,
- 13 Chester County," is repealed.
- 14 Section 3. This act shall take effect immediately.
