AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for application for driver's
- license or learner's permit, for issuance and content of
- driver's license and for expiration and renewal of drivers'
- 5 licenses.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Sections 1506(a) and (a.1), 1510(f) and (i) and
- 9 1514(e) of Title 75 of the Pennsylvania Consolidated Statutes
- 10 are amended to read:
- 11 § 1506. Application for driver's license or learner's permit.
- 12 (a) Form and content. -- Every application for a learner's
- 13 permit or driver's license shall be made upon a form furnished
- 14 by the department and shall contain such information as the
- 15 department may require to determine the applicant's identity,
- 16 competency and eligibility. The form shall allow for submission
- 17 of a Social Security number or a taxpayer identification number.
- 18 The form may also provide for inclusion of personal medical
- 19 information and other information of use in an emergency.

- 1 [(a.1) Noncitizen application. -- A person who is not a
- 2 citizen of the United States may apply for a Pennsylvania
- 3 driver's license upon establishing the person's lawful presence
- 4 in the United States and this Commonwealth. The department may
- 5 issue a license if the person will lawfully be in the United
- 6 States for a period of one year or more after the date of the
- 7 application or for a shorter period of time if deemed
- 8 appropriate by the department.]
- 9 * * *
- 10 § 1510. Issuance and content of driver's license.
- 11 * * *
- 12 (f) Waiver.--Notwithstanding the provisions of subsection
- 13 (a), the department shall issue a driver's license to an
- 14 otherwise eligible person who has no Social Security number if
- 15 the person submits a [waiver obtained from the Federal
- 16 Government permitting him not to have a Social Security number.
- 17 The department may require other identifiers, including, but not
- 18 limited to, a taxpayer identification number, before issuing the
- 19 license.] Federal taxpayer identification number or a Federal_
- 20 waiver for nonissuance of a Social Security number for reasons
- 21 of religion. If an applicant does not have a taxpayer
- 22 <u>identification number, documents or a combination of documents</u>
- 23 that reliably proves the applicant's name, date of birth and
- 24 place of birth shall be submitted. The department shall accept
- 25 the following documents and shall only require a combination of
- 26 them if necessary to establish name, date of birth and place of
- 27 birth of an applicant:
- 28 <u>(1) A valid foreign passport from the person's country</u>
- 29 of citizenship.
- 30 (2) A valid consular identification document issued by

- 1 governments with safety standards and protocols as determined
- 2 <u>by the department.</u>
- 3 (3) A certified record of the applicant's birth,
- 4 <u>marriage</u>, adoption or divorce, including a translation if
- 5 necessary.

- 7 [(i) Issuance to noncitizens.--A license issued in
- 8 accordance with section 1506(a.1) (relating to application for
- 9 driver's license or learner's permit) may contain an indication
- 10 that the license was issued to the person who is not a citizen
- 11 of the United States and who has credentials or documents issued
- 12 by the Immigration and Naturalization Service or its successor.]

- 14 § 1514. Expiration and renewal of drivers' licenses.
- 15 * * *
- 16 [(e) Noncitizen license expiration and renewal.--
- 17 (1) Except as otherwise provided, a license issued on
- 18 the basis of Immigration and Naturalization Service (INS)
- 19 credentials or documents shall expire on the date appearing
- on the INS credentials or documents provided by the applicant
- 21 under section 1506(a.1) (relating to application for driver's
- license or learner's permit).
- 23 (2) If the expiration date of the INS credentials or
- documents exceeds four years, the license shall expire one
- day after the applicant's date of birth but not more than
- 26 four years from the date of issuance of the license.
- 27 (3) Upon presenting INS credentials or documents
- indicating continued legal presence in the United States, the
- 29 person may apply for a renewal of the license.
- 30 (4) If a person has been granted permanent legal status

- in the United States by the INS, the department may in its
- 2 discretion require the person to present his INS credentials
- 3 or documents for only the first license application or
- 4 renewal.
- 5 (5) License renewals issued under this subsection shall
- 6 be for the length of time as set forth in paragraph (1) or
- 7 (2).]
- 8 Section 2. This act shall take effect in 60 days.
