- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An

- laws relating thereto," in duties and powers of boards of 5
- school directors, providing for notice prior to approval of
- 7 collective bargaining agreement.
- The General Assembly of the Commonwealth of Pennsylvania 8
- hereby enacts as follows:
- 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 11 as the Public School Code of 1949, is amended by adding a
- 12 section to read:
- 13 Section 1153-A. Notice Prior to Approval of Collective
- Bargaining Agreement. -- (a) A board of school directors of any 14
- school district shall provide notice prior to voting upon any 15
- 16 proposed collective bargaining agreement. The notice required
- 17 under this section shall:
- 18 (1) Be posted on the school district's publicly accessible

- 1 <u>Internet website beginning at least two (2) weeks FORTY-EIGHT</u>
- 2 (48) HOURS prior to the public meeting of the board of school
- 3 directors at which the board of school directors votes upon the
- 4 proposed collective bargaining agreement and continuing at least
- 5 until THIRTY (30) DAYS FOLLOWING the conclusion of such public <--
- 6 meeting.
- 7 (2) Be published at least one (1) time in a newspaper of
- 8 general circulation in the school district at least two (2)
- 9 <u>weeks FORTY-EIGHT (48) HOURS prior to the public meeting of the</u> <--
- 10 board of school directors at which the board of school directors
- 11 votes upon the proposed collective bargaining agreement.
- 12 <u>(3) Include the following:</u>
- (i) a statement of the terms of the proposed collective
- 14 bargaining agreement; and
- 15 (ii) an estimate of the costs to the school district
- 16 <u>associated with the proposed collective bargaining agreement.</u>
- 17 (b) The notice requirements of this section shall not apply
- 18 <u>to section 1125-A(k).</u>
- 19 (C) THE DEPARTMENT OF EDUCATION SHALL PROMULGATE REGULATIONS <--
- 20 PURSUANT TO THE ACT OF JUNE 25, 1982 (P.L.633, NO.181), KNOWN AS
- 21 THE "REGULATORY REVIEW ACT," TO SET FORTH THE FORM OF THE NOTICE
- 22 REQUIRED UNDER SUBSECTION (A).
- 23 Section 2. This act shall take effect in 60 days.
