AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
2 act relating to the public school system, including certain
3 provisions applicable as well to private and parochial
4 schools; amending, revising, consolidating and changing the
5 laws relating thereto," in grounds and buildings, further
6 providing for acquisition of buildings, sites for school
7 buildings and playgrounds and disposing thereof.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. Section 703 of the act of March 10, 1949 (P.L.30,
11 No.14), known as the Public School Code of 1949, amended June
12 30, 2011 (P.L.112, No.24), is amended to read:

13 Section 703. Acquisition of Buildings, Sites for School
14 Buildings and Playgrounds, and Disposing Thereof.--(a) In order
15 to comply with the provisions of this act, and subject to the
16 conditions thereof, the board of school directors of each
17 district is hereby vested with the necessary power and authority
18 to acquire, in the name of the district, by purchase, lease,

1 gift, devise, agreement, condemnation, or otherwise, any and all
2 schools and real estate, either vacant or occupied, including
3 lands theretofore occupied by streets and alleys which have been
4 vacated by municipal authorities, and to acquire by purchase,
5 lease, gift or devise, other buildings approved for school use
6 by the Department of Education as the board of school directors
7 may deem necessary to furnish school buildings or other suitable
8 sites for proper school purposes for said district or to enlarge
9 the grounds of any school property held by such district, and to
10 sell, convey, transfer, dispose of, or abandon the same, or any
11 part thereof, as the board of school directors may determine.
12 Approval of the Department of Education shall not be required
13 for school buildings and playgrounds on any school construction
14 project for which State reimbursement is not requested.

15 (b) Notwithstanding the provisions of this act or any other
16 provisions of law to the contrary:

17 (1) Where a school district does not request State
18 reimbursement for a school construction project, the school
19 district shall not be required to comply with the provisions of
20 the act of August 15, 1961 (P.L.987, No.442), known as the
21 "Pennsylvania Prevailing Wage Act."

22 (2) Where a board of school directors elects not to comply
23 with the provisions of the Pennsylvania Prevailing Wage Act
24 under this subsection, the board of school directors shall
25 provide the Department of Education with notice in a form
26 prescribed by the Department of Education.

27 (3) The Department of Education may not impose any
28 requirements on a board of school directors under this
29 subsection other than prescribing the form in which the notice
30 shall be provided.

1 Section 2. This act shall take effect in 60 days.
