AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in certification of teachers, further providing for continuing professional development and; PROVIDING FOR BACCALAUREATE CERTIFICATION BASIC SKILLS; AND FURTHER PROVIDING for Pennsylvania School Leadership 8 Standards. 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. Section 1205.1(c.1) of the act of March 10, 1949 13 (P.L.30, No.14), known as the Public School Code of 1949, amended July 11, 2006 (P.L.1092, No.114), is amended to read: 14 15 Section 1205.1. Continuing Professional Development. -- * * * 16 The continuing professional education plan shall 17 specify the professional education needs that will be met by completion of each continuing professional education option and 18 how it relates to areas of assignment and certification or 19

- 1 potential administrative certification. The options may include,
- 2 but shall not be limited to:
- 3 (1) Collegiate studies.
- 4 (2) Continuing professional education courses taken for
- 5 credit.
- 6 (3) Other programs, activities or learning experiences taken
- 7 for credit or hourly, to include:
- 8 (i) curriculum development and other program design and
- 9 delivery activities at the school entity or grade level as
- 10 determined by the school entity and approved by the board of
- 11 directors;
- 12 (ii) participation in professional conferences and
- 13 workshops;
- 14 (iii) education in the workplace, where the work relates to
- 15 the professional educator's area of assignment and is approved
- 16 by the board of directors;
- 17 (iv) review, redesign and restructuring of school programs,
- 18 organizations and functions as determined by the school entity
- 19 and approved by the board of directors;
- 20 (v) in-service programs that comply with guidelines
- 21 established by the department;
- 22 (vi) early childhood and child development activities for
- 23 professional educators whose area of assignment includes
- 24 kindergarten through third grade;
- 25 (vii) special education activities for professional
- 26 educators whose area of assignment includes students with
- 27 special needs;
- 28 (viii) successful completion of department training for
- 29 service as a Distinguished Educator if the professional educator
- 30 participates in and completes at least one assignment in the

- 1 Distinguished Educators Program; [or]
- 2 (ix) other continuing professional education courses,
- 3 programs, activities or learning experiences sponsored by the
- 4 department[.]; or
- 5 (x) visits by educators to a manufacturing workplace, under <--
- 6 which the board of directors approves the professional_
- 7 <u>educator's participation in a site visit to a manufacturing</u>
- 8 location for orientation and demonstrations to give the
- 9 professional educator a greater understanding of job
- 10 opportunities in manufacturing for students.

- 12 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ: <--
- 13 <u>SECTION 1207.3. BACCALAUREATE CERTIFICATION BASIC SKILLS</u>
- 14 ASSESSMENT.--(A) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AN
- 15 ASSESSMENT OF BASIC SKILLS REQUIRED UNDER 22 PA. CODE § 49.18
- 16 (RELATING TO ASSESSMENT) SHALL BE COMPLETED AND A SATISFACTORY
- 17 ACHIEVEMENT LEVEL SHALL BE OBTAINED PRIOR TO ENTRY INTO A
- 18 PENNSYLVANIA BACCALAUREATE TEACHER PREPARATION PROGRAM.
- 19 (B) AN ASSESSMENT OF BASIC SKILLS SHALL NOT BE REQUIRED FOR
- 20 ENTRY INTO A PENNSYLVANIA POSTBACCALAUREATE TEACHER PREPARATION
- 21 PROGRAM OR FOR ANY APPLICANT FOR CERTIFICATION WHO COMPLETES A
- 22 POSTBACCALAUREATE CERTIFICATION PROGRAM OR HOLDS A
- 23 POSTBACCALAUREATE DEGREE.
- 24 (C) NO BACCALAUREATE CERTIFICATION PROGRAM SHALL ADMIT A
- 25 STUDENT WHO HAS NOT MET THE REQUIREMENTS OF THIS SECTION BY
- 26 AUGUST 1, 2015.
- Section $\frac{2}{3}$. Section 1217(a) of the act, added July 20, 2007 <--
- 28 (P.L.278, No.45), is amended to read:
- 29 Section 1217. Pennsylvania School Leadership Standards.--(a)
- 30 Programs provided under section 1205.5(c) and (d) to prepare

- 1 school or system leaders and for purposes of issuing
- 2 administrator certificates or letters of eligibility and
- 3 approved programs for the induction and continuing professional
- 4 education of school or system leaders shall address:
- 5 (1) The following core standards:
- 6 (i) The knowledge and skills to think and plan strategically
- 7 to create an organizational vision around personalized student
- 8 success.
- 9 (ii) An understanding of standards-based systems theory and
- 10 design and the ability to transfer that knowledge to the school
- 11 or system leader's job as the architect of standards-based
- 12 reform in the school.
- 13 (iii) The ability to access and use appropriate data to
- 14 inform decision-making at all levels of the system.
- 15 (2) The following corollary standards:
- 16 (i) Creating a culture of teaching and learning with an
- 17 emphasis on learning, including teaching and learning in
- 18 manufacturing and vocational fields.
- 19 (ii) Managing resources for effective results.
- 20 (iii) Collaborating, communicating, engaging and empowering
- 21 others inside and outside of the organization to pursue
- 22 excellence in learning.
- 23 (iv) Operating in a fair and equitable manner with personal
- 24 and professional integrity.
- 25 (v) Advocating for children and public education in the
- 26 larger political, social, economic, legal and cultural context.
- 27 (vi) Supporting professional growth of self and others
- 28 through practice and inquiry.
