AN ACT

- Designating a bridge in Greene County as the Lieutenant Colonel Cephus Lee Roupe Memorial Bridge.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Lieutenant Colonel Cephus Lee Roupe Memorial Bridge.
- 6 (a) Findings and declarations. -- The General Assembly finds
- 7 and declares as follows:
- 8 (1) Lieutenant Colonel Cephus Lee Roupe was born on
- 9 November 7, 1957, in Waynesburg, Pennsylvania, and passed
- away at 54 years of age on March 2, 2012, of natural causes.
- 11 (2) Lieutenant Colonel Roupe proudly and courageously
- 12 served his country in the United States Army for 36 years.
- 13 (3) Lieutenant Colonel Roupe began his career as an
- 14 enlisted soldier and excelled through the ranks. When
- 15 Lieutenant Colonel Roupe was an E-5 (SGT) he applied and was

- 1 accepted into flight school in which he received his aviation
- wings at Fort Rucker, Alabama, as a Warrant Officer.
- 3 (4) Lieutenant Colonel Roupe was a former Warrant
- 4 Officer who received a direct commission appointment to the
- 5 Medical Service Corps and was qualified in the UH-1, AH-1,
- 6 UH-60, T-42, U-21 and C-12 aircraft.
- 7 (5) Lieutenant Colonel Roupe was one of the most
- 8 experienced Medical Service Corps aviators and was a Master
- 9 Army Aviator and a combat veteran of Operation Desert Storm,
- 10 the Bosnian War Operation Joint Endeavor and two tours in
- 11 Iraq Operation Iraqi Freedom, and Afghanistan Operation
- 12 Enduring Freedom.
- 13 (b) Designation. -- The bridge that carries State Route 18,
- 14 Section D10, Segment 0070, Offset 0038, over Fish Creek in New
- 15 Freeport Township, Greene County, is designated as the
- 16 Lieutenant Colonel Cephus Lee Roupe Memorial Bridge.
- 17 (c) Signs. -- The Department of Transportation shall erect and
- 18 maintain appropriate signs displaying the name of the bridge to
- 19 traffic in both directions on the bridge.
- 20 Section 2. Effective date.
- 21 This act shall take effect immediately.
