AN ACT

- 1 Providing for hepatitis C testing and treatment and for duties 2 of the Department of Health.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Hepatitis C
- 7 Screening Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Department." The Department of Health of the Commonwealth.
- "Health care facility." As defined in section 802.1 of the
- 14 act of July 19, 1979 (P.L.130, No.48), known as the Health Care
- 15 Facilities Act.
- 16 "Health care practitioner." As defined in section 103 of the

- 1 act of July 19, 1979 (P.L.130, No.48), known as the Health Care
- 2 Facilities Act.
- 3 "Health care provider." As defined in section 103 of the act
- 4 of July 19, 1979 (P.L.130, No.48), known as the Health Care
- 5 Facilities Act.
- 6 "Hepatitis C diagnostic test." Any laboratory test or tests
- 7 that detect the presence of hepatitis C virus in the blood and
- 8 provide confirmation of whether an individual has a hepatitis C
- 9 virus infection.
- 10 "Hepatitis C screening test." Any laboratory screening test
- 11 or tests that detect the presence of hepatitis C virus
- 12 antibodies in the blood.
- 13 "Hospital." As defined in section 802.1 of the act of July
- 14 19, 1979 (P.L.130, No.48), known as the Health Care Facilities
- 15 Act.
- 16 "Physician." As defined in section 2 of the act of December
- 17 20, 1985 (P.L.457, No.112), known as the Medical Practice Act of
- 18 1985.
- 19 "Primary care." Health care that emphasizes a patient's
- 20 general health needs and utilizes collaboration with other
- 21 health care professionals and consultation or referral as
- 22 appropriate to meet the needs identified.
- 23 Section 3. Hepatitis C screening.
- 24 (a) Requirement.--Each individual born between the years of
- 25 1945 and 1965 who receives health services as an inpatient in a
- 26 hospital or who receives primary care services in an outpatient
- 27 department of a hospital, health care facility or physician's
- 28 office shall be offered a hepatitis C screening test or
- 29 hepatitis C diagnostic test unless the health care practitioner
- 30 providing the services reasonably believes at least one of the

- 1 following:
- 2 (1) The individual is being treated for a life-
- 3 threatening emergency.
- 4 (2) The individual has previously been offered or has
- 5 been the subject of a hepatitis C screening test, except that
- a test shall be offered if otherwise indicated.
- 7 (3) The individual lacks capacity to consent to a
- 8 hepatitis C screening test.
- 9 (b) Follow-up health care.--If an individual accepts the
- 10 offer of a hepatitis C screening test and the screening test is
- 11 reactive, the health care provider shall either offer the
- 12 individual follow-up health care or refer the individual to a
- 13 health care provider who can provide follow-up health care. The
- 14 follow-up health care shall include a hepatitis C diagnostic
- 15 test.
- 16 Section 4. Reporting.
- 17 (a) Department.--On or before January 1, 2016, the
- 18 department shall evaluate and report on the impact of this act
- 19 with respect to:
- 20 (1) The number of persons who are screened for hepatitis
- 21 C.
- 22 (2) The number of persons who have accessed care
- following a positive test for hepatitis C.
- 24 (b) Submission. -- The report shall be submitted to the
- 25 Governor and to the chairman and minority chairman of the Public
- 26 Health and Welfare Committee of the Senate and the chairman and
- 27 minority chairman of the Health Committee of the House of
- 28 Representatives.
- 29 Section 5. Licensed practitioners.
- 30 This act shall not affect the scope of practice of any health

- 1 care practitioner or diminish any authority or legal or
- 2 professional obligation of any health care practitioner to offer
- 3 a hepatitis C screening test or hepatitis C diagnostic test or
- 4 to provide services or care for the subject of a hepatitis C
- 5 screening test or hepatitis C diagnostic test.
- 6 Section 6. Duties of department.
- 7 The offering of hepatitis C screening testing under this act
- 8 shall be culturally and linguistically appropriate in accordance
- 9 with regulations promulgated by the department.
- 10 Section 7. Effective date.
- 11 This act shall take effect in 60 days.
