Section 4503(a) of Title 42 of the Pennsylvania Consolidated Statutes is amended by adding a paragraph 8 <--PARAGRAPHS to read: <--10 § 4503. Exemptions from jury duty. 11 General rule. -- No person shall be exempt or excused from jury duty except the following: 12 * * * 13 14 (6) Persons 75 years of age or older who opt not to 15 serve. (7) BREASTFEEDING WOMEN PROVIDING THE COURT WITH A 16 <--17 CERTIFIED LETTER FROM THEIR PHYSICIAN WHICH STATES THAT THE

- 1 WOMAN IS BREASTFEEDING. AN EXCUSE UNDER THIS PARAGRAPH SHALL
- 2 BE VALID FOR ONE YEAR AND MAY BE RENEWED FOR ONE ADDITIONAL
- 3 YEAR PROVIDED THAT THE WOMAN IS ABLE TO PROVIDE THE COURT
- 4 <u>WITH A CERTIFIED LETTER FROM THE WOMAN'S PHYSICIAN WHICH</u>

- 11 <u>(c) Persons aged 75 years or older.--A person who is exempt</u>
- 12 or excused from jury duty under section 4503(a)(6) (relating to
- 13 exemptions from jury duty) may petition the jury selection
- 14 commission to have the person's name placed on the list of
- 15 <u>disqualified jurors. A person placed on the list may, at any</u>
- 16 time, petition for removal of the person's name from the list
- 17 unless the person is disqualified under section 4502 (relating
- 18 to qualifications of jurors).
- 19 Section 3. This act shall take effect in 60 days.
