AN ACT

- Amending the act of December 19, 1990 (P.L.1372, No.212), entitled "An act providing for early intervention services 2 for infants, toddlers and preschool children who qualify; 3 establishing the Interagency Coordinating Council and providing for its powers and duties; and conferring powers and duties upon the Department of Education and the State 6 Board of Education, the Department of Health and the 7 Department of Public Welfare, " further providing for 8 definitions and for child identification, assessment and 9 tracking system; AND MAKING AN APPROPRIATION. <--10
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Section 103 of the act of December 19, 1990
- 14 (P.L.1372, No.212), known as the Early Intervention Services
- 15 System Act, is amended by adding a definition to read:
- 16 Section 103. Definitions.
- 17 The following words and phrases when used in this act shall
- 18 have the meanings given to them in this section unless the
- 19 context clearly indicates otherwise:

- 1 * * *
- 2 "Homeless." An individual who lacks a fixed, regular and
- 3 adequate nighttime residence. The term includes:
- 4 <u>(1) Children and youth in any of the following:</u>
- 5 <u>(i) Who are sharing the housing of another person</u>
- due to loss of housing, economic hardship or a similar
- 7 <u>reason.</u>
- 8 <u>(ii) Who are living in a motel, hotel, trailer park</u>
- 9 <u>or camping grounds due to the lack of alternative</u>
- 10 <u>adequate accommodations.</u>
- 11 (iii) Who are living in an emergency or transitional
- 12 <u>shelter.</u>
- 13 (iv) Who are abandoned in a hospital.
- 14 (v) Who are awaiting foster care placement.
- (vi) Who have a primary nighttime residence that is
- a public or a private place not designed for or
- 17 ordinarily used as a regular sleeping accommodation for
- 18 human beings.
- 19 (vii) Who are living in a car, park, public space,
- abandoned building, substandard housing, bus or train
- 21 station or similar setting.
- (2) migratory children who qualify as homeless for the
- 23 purposes of this chapter because the child is living in one
- of the circumstances in paragraph (1).

- 26 Section 2. Section 305(b) of the act is amended to read:
- 27 Section 305. Child identification, assessment and tracking
- 28 system.

- 30 (b) At-risk children.--For the purposes of child

- 1 identification, assessment and tracking for infants and
- 2 toddlers, the Department of Public Welfare shall establish, by
- 3 regulation, population groups to be included in these
- 4 activities. The population groups shall include, but not be
- 5 limited to, children whose birth weight is under 1,500 grams;
- 6 children cared for in neonatal intensive care units of
- 7 hospitals; children born to chemically dependent mothers and
- 8 referred by a physician, health care provider or parent;
- 9 children who are seriously abused or neglected, as substantiated
- 10 and referred by the county children and youth agency under the
- 11 act of November 26, 1975 (P.L.438, No.124), known as the Child
- 12 Protective Services Law; [and] children with confirmed dangerous
- 13 levels of lead poisoning as set by the Department of Health; and
- 14 <u>children who are homeless</u>. The Department of Public Welfare may
- 15 establish other population groups by regulation as it deems
- 16 necessary.

- 18 SECTION 3. THE SUM OF \$640,000, OR AS MUCH THEREOF AS MAY BE <--
- 19 NECESSARY, IS HEREBY APPROPRIATED TO THE DEPARTMENT OF PUBLIC
- 20 WELFARE FOR THE FISCAL YEAR JULY 1, 2014, TO JUNE 30, 2015, FOR
- 21 THE PROVISION OF EARLY INTERVENTION SERVICES TO HOMELESS INFANTS
- 22 AND TODDLERS.
- 23 Section $\frac{3}{4}$. This act shall take effect immediately. <--
