AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," in public assistance,
- further providing for responsibilities and obligations of
- department, applicants and recipients.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 405.3(a)(6) of the act of June 13, 1967
- 9 (P.L.31, No.21), known as the Public Welfare Code, amended May
- 10 16, 1996 (P.L.175, No.35), is amended to read:
- 11 Section 405.3. Responsibilities and Obligations of
- 12 Department, Applicants and Recipients. -- (a) Subject to Federal
- 13 approval, only where necessary, each adult applicant or
- 14 recipient of cash assistance or other person who is required to
- 15 sign an application for assistance shall be required as a
- 16 condition of eligibility to enter into a mutual agreement with
- 17 the department that will set forth the responsibilities and
- 18 obligations to be undertaken by the recipient to achieve self-
- 19 sufficiency, the time frames within which each obligation is to

- 1 be completed, the penalties for failure to comply and the
- 2 actions to be taken by the department to support the efforts of
- 3 the applicant or recipient. Where appropriate, these obligations
- 4 shall include, but not be limited to:
- 5 * * *
- 6 (6) Maintaining the health and well-being of his or her
- 7 children, including:
- 8 (i) ensuring that children attend school and pursue a high
- 9 school diploma or its equivalent;
- 10 (ii) ensuring that children receive immunizations,
- 11 appropriate health screenings and necessary medical treatment,
- 12 consistent with nationally recognized standards;
- 13 (iii) performing any other appropriate activity based on an
- 14 assessment of the education level, parenting skills and history
- 15 of parenting activities and involvement of each parent who is
- 16 applying for assistance;
- 17 (iv) volunteering at the children's school based on the
- 18 <u>needs of the school, for a period as determined by regulations</u>
- 19 promulgated by the department;
- 20 <u>(v)</u> meeting other requirements as established by the
- 21 department.

- 23 Section 2. This act shall take effect in 60 days.
