AN ACT

- 1 Requiring the Environmental Quality Board to differentiate
- regulations relating to conventional oil and gas wells and
- unconventional gas wells in this Commonwealth.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Pennsylvania
- 8 Conventional Oil and Gas Well Regulation Act.
- 9 Section 2. Legislative findings and declarations.
- 10 The General Assembly finds and declares as follows:
- 11 (1) The conventional oil and gas industry has had a
- 12 benign impact on human health and the environment in this
- 13 Commonwealth since the former act of December 19, 1984
- 14 (P.L.1140, No.223), known as the Oil and Gas Act, was
- 15 enacted.
- 16 (2) Small businesses, which are often located in small

- 1 towns and rural areas of this Commonwealth, have
- 2 traditionally comprised much of the conventional oil and gas
- 3 industry in this Commonwealth.
- 4 (3) Regulations for the conventional oil and gas
- 5 industry must permit the optimal development of oil and gas
- 6 resources of this Commonwealth, protect the health, safety,
- 7 environment and property of the citizens of this Commonwealth
- 8 and not unreasonably hamper the ability of this Commonwealth
- 9 to compete effectively with other states.
- 10 (4) The provisions of 58 Pa.C.S. (relating to oil and
- gas) create standards for unconventional gas wells that are
- not applicable to conventional oil and gas wells.
- 13 (5) The regulations promulgated by the Environmental
- Quality Board under 58 Pa.C.S. and other laws of this
- 15 Commonwealth relating to conventional oil and gas wells or
- unconventional gas wells should differentiate between
- 17 conventional oil and gas wells and unconventional gas wells.
- 18 Section 3. Definitions.
- 19 The following words and phrases when used in this act shall
- 20 have the meanings given to them in this section unless the
- 21 context clearly indicates otherwise:
- "Conventional oil and gas well." A bore hole drilled for the
- 23 purpose of producing oil or gas from a conventional formation.
- 24 Irrespective of technology or design, the THE term includes any <--
- 25 of the following:
- 26 (1) A well drilled to produce oil.
- 27 (2) A well drilled to produce natural gas from
- 28 formations other than shale formations.
- 29 (3) A well drilled to produce natural gas from shale
- 30 formations located above the base of the Elk Group or its

- 1 stratigraphic equivalent.
- 2 (4) A well drilled to produce natural gas from shale
 3 formations located below the base of the Elk Group where
 4 natural gas can be produced at economic flow rates or in
 5 economic volumes without the use of vertical or nonvertical
 6 well bores stimulated by hydraulic fracture treatments or by
 7 using multilateral well bores or other techniques to expose
 8 more of the formation to the well bore.
- 9 (5) Irrespective of formation, a well drilled for 10 collateral purposes, such as monitoring, geologic logging, 11 secondary and tertiary recovery or disposal injection.
- "Unconventional formation." A geological shale formation
- 13 existing below the base of the Elk Sandstone or its geologic
- 14 stratigraphic equivalent where natural gas generally cannot be
- 15 produced at economic flow rates or in economical volumes except
- 16 by vertical or horizontal well bores stimulated by hydraulic
- 17 fracture treatments or by using multilateral well bores or other
- 18 techniques to expose more of the formation to the well bore.
- "Unconventional gas well." A bore hole drilled for the
- 20 purpose of producing gas from an unconventional formation.
- 21 Section 4. Oil and gas well regulations.
- 22 (a) General rule. -- Regulations PROPOSED REGULATIONS OR
- 23 REGULATIONS promulgated by the Environmental Quality Board under

- 24 58 Pa.C.S. (relating to oil and gas) or other laws of this
- 25 Commonwealth relating to conventional oil and gas wells or
- 26 unconventional gas wells shall differentiate between
- 27 conventional oil and gas wells and unconventional gas wells.
- 28 (b) Codification. -- Regulations under subsection (a) that
- 29 apply to conventional oil and gas wells shall be separate from
- 30 regulations that apply to unconventional gas wells.

- 1 Section 5. Applicability.
- 2 This act shall apply to regulations promulgated on or after
- 3 the effective date of this section.
- 4 Section 6. Effective date.
- 5 This act shall take effect immediately.
