AN ACT

- 1 Amending Title 35 (Health and Safety) of the Pennsylvania
- 2 Consolidated Statutes, further providing for definitions and
- 3 for laws suspended during emergency assignments.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 7102 of Title 35 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding definitions to read:
- 8 § 7102. Definitions.
- 9 The following words and phrases when used in this part shall
- 10 have, unless the context clearly indicates otherwise, the
- 11 meanings given to them in this section:
- 12 * * *
- "Disaster emergency-related work." The repair, renovation,
- 14 installation, construction or rendering of services or other
- 15 business activities that relate to infrastructure that has been
- 16 damaged, impaired or destroyed by a disaster.
- 17 * * *

- 1 <u>"Infrastructure."</u> Real and personal property and equipment
- 2 that is owned or used by any of the following that service
- 3 <u>multiple customers or citizens:</u>
- 4 <u>(1) A communications network.</u>
- 5 (2) An electric generation, transmission and
- 6 <u>distribution system.</u>
- 7 (3) A gas distribution system.
- 8 <u>(4) A water pipeline, public road and bridge-related</u>
- 9 <u>support facility.</u>
- 10 * * *
- "Out-of-State business." A business entity whose services
- 12 <u>are requested by a registered business, the Commonwealth or a</u>
- 13 political subdivision of the Commonwealth for purposes of
- 14 performing disaster emergency-related work in this Commonwealth.
- 15 The term includes a business entity that is affiliated with a
- 16 registered business in this Commonwealth solely through common
- 17 ownership. The out-of-State business may not have any of the
- 18 <u>following:</u>
- 19 (1) A presence in this Commonwealth, excluding prior
- 20 disaster emergency-related work performed under section
- 21 7308(b)(1) (relating to laws suspended during emergency
- 22 assignments).
- 23 (2) Any registration, tax filing or nexus in this
- 24 Commonwealth within the past three calendar years.
- 25 "Out-of-State employee." An employee who does not work in
- 26 this Commonwealth, unless the employee is performing disaster
- 27 <u>emergency-related work during a period under section 7308(b)(1).</u>
- 28 * * *
- 29 "Registered business." Any business entity that is
- 30 registered to do business in this Commonwealth prior to a

- 1 declared disaster or emergency.

- 3 Section 2. Section 7308 of Title 35 is amended to read:
- 4 § 7308. Laws suspended during emergency assignments.
- 5 (a) Commonwealth agencies. -- In the case of a declaration of
- 6 a state of emergency by the Governor, Commonwealth agencies may
- 7 implement their emergency assignments without regard to
- 8 procedures required by other laws (except mandatory
- 9 constitutional requirements) pertaining to the performance of
- 10 public work, entering into contracts, incurring of obligations,
- 11 employment of temporary workers, rental of equipment, purchase
- 12 of supplies and materials and expenditures of public funds.
- 13 (b) Out-of-State business or employee. -- Notwithstanding any
- 14 other law to the contrary, if the Governor has declared a
- 15 <u>disaster emergency to exist under this part or the President has</u>
- 16 <u>declared a major disaster or emergency to exist in this</u>
- 17 Commonwealth, the following shall apply:
- 18 <u>(1) An out-of-State business that conducts operations</u>
- within this Commonwealth for purposes of performing disaster
- 20 emergency-related work for a period of not more than ten days
- 21 before or not more than 60 calendar days after the end of the
- declared disaster emergency period may not be considered to
- 23 have established a level of presence that would require that
- business to register, file and remit State or local taxes, or
- 25 that would require the out-of-State business or an out-of-
- 26 State employee to be subject to any licensing or registration
- 27 <u>requirements of the Commonwealth, provided that the out-of-</u>
- 28 State business is in substantial compliance with all
- 29 applicable regulatory and licensing requirements in its state
- of domicile, including any of the following:

Τ	(1) State or local business licensing or
2	registration requirements.
3	(ii) Pennsylvania Public Utility Commission or
4	regulatory requirements.
5	(iii) State and local taxes and fees, such as
6	unemployment insurance, sales and use tax or property tax
7	on equipment brought in this Commonwealth on a temporary
8	basis used or consumed in this Commonwealth, State or
9	local occupational licensing fees or local services
10	taxes.
11	(iv) A State or local tax on or measured by, in
12	whole or in part, net or gross income or receipts.
13	(2) The period under paragraph (1) may be extended by
14	the Governor for a period of not more than 30 days for each
15	declared disaster emergency.
16	(3) An out-of-State employee shall not be considered to
17	have established residency or presence in this Commonwealth
18	that would require the individual or the individual's
19	employer to file and pay income taxes, to be subjected to
20	income tax withholding or to file and pay any other State or
21	local tax or fee for disaster emergency-related work
22	performed during the disaster period designated under
23	paragraphs (1) and (2), including any related State or local
24	employer withholding or remittance obligations.
25	Section 3. The following provisions shall apply to a
26	disaster or emergency that is declared on or after the effective
27	date of this section:
28	(1) The addition of the definitions of "disaster
29	emergency-related work," "infrastructure," "out-of-State
30	business," "out-of-State employee" and "registered business"
