## AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, in burglary and other criminal 2 intrusion, further providing for the offense of criminal 4 trespass. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: Section 1. Section 3503(d) of Title 18 of the Pennsylvania 7 Consolidated Statutes is amended and the section is amended by 8 adding a subsection to read: 10 § 3503. Criminal trespass. 11 (b.4) Evaluation for gambling disorder.--12 13 (1) Upon conviction, adjudication or plea of nolo 14 contendere, including admission to Accelerated Rehabilitative 15 Disposition or other pre-trial diversion program of a person 16 for an offense committed under subsection (b) or (b.1), where 17 the person's name is included on a self-exclusion list and the offense was committed at a licensed facility, the court 18

- 1 <u>may direct that the person be evaluated in a manner deemed</u>
- 2 <u>appropriate by the court to determine if:</u>
- 3 <u>(i) the person has a gambling disorder; and</u>
- 4 <u>(ii) whether there is a need for counseling or</u>
- 5 <u>treatment as part of the sentence or preadjudication</u>
- 6 disposition.
- 7 (2) The evaluation shall be conducted by a single county
- 8 <u>authority for drug and alcohol or its designee and shall</u>
- 9 include recommendations for levels of care, continuing care
- 10 and monitoring.

- 12 (d) [Definition.--As used in this section, the term "school
- 13 grounds" means any] <u>Definitions.--As used in this section the</u>
- 14 following words and phrases shall have the meanings given to
- 15 them in this subsection:
- 16 <u>"Evaluation." An assessment performed by a clinician who</u>
- 17 meets the minimum qualifications prescribed by the Department of
- 18 Drug and Alcohol Programs for the provision of gambling disorder
- 19 counseling.
- 20 "Licensed gaming entity." As defined in 4 Pa.C.S. § 1103
- 21 (relating to definitions).
- 22 "Licensed facility." As defined in 4 Pa.C.S. § 1103.
- 23 "School grounds." Any building of or grounds of any
- 24 elementary or secondary publicly funded educational institution,
- 25 any elementary or secondary private school licensed by the
- 26 Department of Education, any elementary or secondary parochial
- 27 school, any certified day-care center or any licensed preschool
- 28 program.
- 29 "Self-exclusion list." The list established and maintained
- 30 by the Pennsylvania Gaming Control Board under 4 Pa.C.S. § 1516

- 1 (relating to list of persons self excluded from gaming
- 2 <u>activities</u>) or a self-exclusion list maintained by a licensed
- 3 gaming entity which meets the minimum criteria stated in 4
- 4 <u>Pa.C.S.</u> § 1516.
- 5 Section 2. This act shall take effect in 60 days.
