AN ACT

- Amending the act of May 17, 1921 (P.L.789, No.285), entitled, as 1 amended, "An act relating to insurance; establishing an 2 insurance department; and amending, revising, and consolidating the law relating to the licensing, qualification, regulation, examination, suspension, and dissolution of insurance companies, Lloyds associations, 5 6 reciprocal and inter-insurance exchanges, and certain 7 societies and orders, the examination and regulation of fire 8 insurance rating bureaus, and the licensing and regulation of 9 insurance agents and brokers; the service of legal process 10 upon foreign insurance companies, associations or exchanges; 11 providing penalties, and repealing existing laws," providing 12 for life insurance database. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. The act of May 17, 1921 (P.L.789, No.285), known 17 as The Insurance Department Act of 1921, is amended by adding a 18 section to read: 19 Section 207A. Life Insurance Database. -- (a) The Insurance Department shall maintain an electronic database of contact 20 21 information for each life insurer that has life insurance
- 22 policies in force in this Commonwealth.

- 1 (b) Beginning on January 1, 2015, any member of the
- 2 <u>immediate family</u>, executor or administrator of a decedent who is
- 3 searching for life insurance policies covering the decedent may
- 4 file a request with the department for a search pursuant to this
- 5 <u>section</u>, provided the decedent was a resident or former resident
- 6 of this Commonwealth. The request shall include a copy of the
- 7 <u>decedent's death certificate</u>. The right to file a request for a
- 8 search pursuant to this section may not be assigned.
- 9 (c) The department shall transmit a search request to all
- 10 life insurers having life insurance policies in force in this
- 11 Commonwealth, along with information necessary for responding
- 12 <u>directly to the person filing the request. Each insurer shall</u>
- 13 <u>examine its books and records to determine whether the decedent</u>
- 14 <u>is covered by a life insurance policy</u>, and upon a finding that
- 15 coverage does exist, the insurer shall directly notify the
- 16 person filing the request.
- 17 (d) Insurers of credit life insurance, as defined in section
- 18 <u>2 of the act of September 2, 1961 (P.L.1232, No.540), known as</u>
- 19 the "Model Act for the Regulation of Credit Life Insurance and
- 20 <u>Credit Accident and Health Insurance," are exempt from the</u>
- 21 provisions of this act.
- 22 (e) The department may charge ten dollars (\$10) for each
- 23 search request processed through the database. Beginning one
- 24 year after the effective date of this section the department
- 25 shall have authority to increase the fee charged. The fee
- 26 <u>increase shall not:</u>
- 27 (1) exceed an annual cost-of-living adjustment as calculated
- 28 by applying the percentage increase in the Consumer Price Index
- 29 <u>for All Urban Consumers (CPI-U) for the Pennsylvania, New</u>
- 30 <u>Jersey</u>, <u>Delaware and Maryland area for the most recent 12-month</u>

- 1 period for which figures have been officially reported by the
- 2 <u>United States Department of Labor, Bureau of Labor Statistics;</u>
- 3 and
- 4 (2) exceed twenty per centum (20%) annually.
- 5 (f) The department may adopt rules and regulations to
- 6 <u>implement the provisions of this section.</u>
- 7 (g) For purposes of this section, the term "immediate
- 8 family" means a parent, spouse, child, brother or sister.
- 9 Section 2. This act shall take effect January 1, 2015.
