- 6 WHEREAS, Petty Officer 1st Class Nicolas D. Checque was
- 7 raised in western Pennsylvania, graduating in 2002 from Norwin
- 8 High School where he was a member of the wrestling team and
- 9 classmates describe him as an "extraordinary, driven young man";
- 10 and
- 11 WHEREAS, Petty Officer 1st Class Nicolas D. Checque joined
- 12 the Navy in 2002 after graduating from high school and after
- 13 receiving training joined the SEAL program in April 2003; and

- 1 WHEREAS, Petty Officer 1st Class Nicolas D. Checque received
- 2 the Bronze star and several other awards during his ten-year
- 3 career; and
- 4 WHEREAS, Petty Officer 1st Class Nicolas D. Checque was a
- 5 member of the Navy's Special Warfare Development Group, more
- 6 commonly known as SEAL Team Six, the same unit that took part in
- 7 the raid that killed al Qaeda leader Osama bin Laden;
- 8 WHEREAS, Petty Officer 1st Class Nicolas D. Checque sustained
- 9 fatal injuries during his participation in SEAL Team Six's
- 10 successful rescue of a captive doctor and two aid workers in
- 11 Afghanistan; therefore be it
- 12 RESOLVED, That the House of Representatives honor the life
- 13 and extend condolences for the supreme sacrifice of United
- 14 States Navy Petty Officer 1st Class Nicolas D. Checque, who
- 15 tragically died of combat-related injuries suffered December 8,
