- 6 WHEREAS, Mr. Miller began his service as a Junior Volunteer
- 7 Firefighter at 16 years of age, rising through the ranks to
- 8 become 1st Assistant Fire Chief, and ultimately Chief in 2001;

- 10 WHEREAS, Mr. Miller was born on February 6, 1968, in York,
- 11 attended Dallastown Area School District and graduated from York
- 12 County Area Vocational-Technical School, Class of 1986; and
- 13 WHEREAS, Mr. Miller was a tool and die maker by trade and was

- 2 mentoring young firefighters; and
- 3 WHEREAS, Mr. Miller was a member of Salem United Church of
- 4 Christ in Jacobus, and was an active member of the Loganville
- 5 Fire Company, the Seven Valleys Community Fire Company and the
- 6 Fire Chiefs Association; and
- 7 WHEREAS, Mr. Miller is survived by his wife of 21 years,
- 8 Michelle D. "Shelly" (Keener) Miller; his parents, Paul T. and
- 9 Elaine M. (Thoman) Miller of Seven Valleys; his brother, Gary L.
- 10 Miller and his wife Julie of Spring Grove; three nieces, Lindsay
- 11 M. Miller, Madison M. Luring and Mariah E. Luring; and a nephew,
- 12 Kyle A. Miller; and
- 13 WHEREAS, A funeral service was held Friday, May 3, 2013, at
- 14 Grace Fellowship Church in York, and Mr. Miller was laid to rest
- 15 in St. Peter's Yellow Church Cemetery in Seven Valleys and
