## A RESOLUTION

1 Honoring female veterans who heroically served our country as  
2 members of the armed forces.

3 WHEREAS, Women have served in our armed forces since the  
4 Civil War; and

5 WHEREAS, An estimated 435,000 women served in World War I and  
6 World War II; and

7 WHEREAS, While the total veteran population is decreasing,  
8 the number of female veterans continues to increase; and

9 WHEREAS, Between 1990 and 2008, the women veteran population  
10 increased from 1,200,000 to 1,800,000; and

11 WHEREAS, As of September of 2010, the total veteran  
12 population in the United States and Puerto Rico was  
13 approximately 23,000,000, with women numbering 1,840,380; and

1       WHEREAS, It is projected that women veterans will represent  
2 more than 10% of the total veteran population by 2020; and

3       WHEREAS, According to the United States Department of  
4 Veterans Affairs, there are in excess of 79,000 female veterans  
5 in Pennsylvania; therefore be it

6       RESOLVED, That the House of Representatives honor female  
7 veterans who heroically served our country as members of the  
8 armed forces.
