INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, MARCH 11, 2014

A RESOLUTION

- Designating March 20, 2014, as "March for Meals Day" in Pennsylvania.
- 3 WHEREAS, Hunger among senior citizens in America is a serious
- 4 and pervasive problem, as one in seven seniors is threatened by
- 5 hunger; and
- 6 WHEREAS, Research indicates that 8.3 million seniors faced
- 7 the threat of hunger in 2010, which reflects a 78% increase
- 8 since 2001; and
- 9 WHEREAS, Since the economic recession began in 2007, there
- 10 has been a 34% increase in senior hunger and the threat of
- 11 hunger for seniors increased in 44 states; and
- 12 WHEREAS, The Meals on Wheels Association of America (MOWAA)
- 13 annually sponsors the March for Meals campaign, which is
- 14 designed to raise awareness of senior hunger and encourage
- 15 action at the local level; and

- 1 WHERAS, Senior nutrition programs across the United States
- 2 promote March for Meals in their communities through public
- 3 events, volunteer recruitment efforts, partnerships with local
- 4 businesses and fundraising initiatives; and
- 5 WHEREAS, The MOWAA is the oldest and largest national
- 6 organization composed of and representing local, community-based
- 7 senior nutrition programs in all 50 states, as well as the
- 8 United States Territories; and
- 9 WHEREAS, There are approximately 5,000 local senior nutrition
- 10 programs in the United States, which daily provide more than 1
- 11 million meals to seniors who need them; and
- 12 WHEREAS, There are between 800,000 and 1.7 million individual
- 13 volunteers involved in these programs, which is the largest
- 14 volunteer army in the nation; and
- WHEREAS, On September 1, 2009, the MOWAA Board of Directors
- 16 approved a new vision for the MOWAA, which is to end senior
- 17 hunger by the year 2020; and
- 18 WHEREAS, To achieve this mission, MOWAA has set a goal of
- 19 recruiting 6 million people who are willing to stand up and
- 20 pledge to do what it takes to end senior hunger; and
- 21 WHEREAS, The annual March for Meals campaign should continue
- 22 to contribute significantly toward realizing this ambitious and
- 23 most worthy goal, and citizens of this Commonwealth are
- 24 encouraged to participate in this effort to fight senior citizen
- 25 hunger; therefore be it
- 26 RESOLVED, That the House of Representatives designate March
- 27 20, 2014, as "March for Meals Day" in Pennsylvania.
