## A RESOLUTION

1 2 3	VonRueden and expressing condolences to their families upon their untimely and tragic passing.
4	WHEREAS, Francis James Keenan, 28, of Clarks Summit and his
5	climbing partner, Jarod VonRueden, 22, of Clyman in Dodge
6	County, Wisconsin, began a climb to the top of the nearly
7	23,000-foot Mount Aconcagua in the Andes Mountain Range, the
8	highest peak in North and South America, on December 20, 2013;
9	and
10	WHEREAS, Mr. Keenan and Mr. VonRueden began their climb up
11	the Polish Glacier after qualifying for and receiving the
12	required permits; and
13	WHEREAS, Mr. Keenan and Mr. VonRueden reached the top of the
14	mountain, one of the famed Seven Summits, nearly four miles
15	above the Province of Mendoza in Argentina on December 31, 2013;

2 WHEREAS, Mr. Keenan and Mr. VonRueden began to make the climb 3 down when authorities received an alert from a rescue beacon 4 registered to Mr. VonRueden, prompting a search for the 5 climbers; and

6 WHEREAS, The search and rescue turned into a recovery mission 7 when a helicopter crew spied their bodies at the bottom of a 8 crevasse; and

9 WHEREAS, Authorities reasoned that bad weather led the 10 climbers to attempt to rappel down a cliff into camps lower down 11 the mountain; and

12 WHEREAS, Tragically, their climbing anchors failed to hold 13 them, causing them to fall together more than 600 feet to their 14 deaths; and

15 WHEREAS, Recovery crews could not reach the men's bodies 16 until the last week of February 2014 due to strong gales, bitter 17 cold and stormy weather coupled with the rarely used route taken 18 by the two climbers and the desire to put recovery crews in as 19 little danger as possible; and

WHEREAS, The unfortunate deaths occurred despite Mr. Keenan's
and Mr. VonRueden's being experienced climbers; and
WHEREAS, Mr. Keenan successfully summitted Mount Rainier,
Mount Baker, Mount Adams and Mount Shuksan in the State of
Washington; Mount Shasta in the State of California; Mount
Cotopaxi, Mount Cayambe and Mount Chimborazo in Ecuador and

26 Mount Orizaba in Mexico; and

27 WHEREAS, Mr. VonRueden climbed Mount McKinley in the State of 28 Alaska, scaled various peaks in Ecuador, backpacked in China and 29 through the Grand Canyon and rode a bicycle from Wisconsin to 30 Montana; and

WHEREAS, Mr. Keenan was the son of Diane Lozinger-Keenan of
 Clarks Summit and the late James Keenan, and graduated in 2003
 from Abington Heights High School; and

WHEREAS, During his high school years, Mr. Keenan earned membership in the National Honor Society and participated in Rotary Leadership Camp, National History Day regional and State competitions, Sons of the Union Veterans of the Civil War, National Geographic Society, National Academy of Science, marching band, student council and the Pennsylvania Gettysburg Monuments Project; and

11 WHEREAS, Mr. Keenan's papers, as a part of his winning the 12 National History Day national, State and regional competitions, 13 focused on the military service of his family members, including 14 his grandfather, Edmund Carr in World War II; his father, James 15 Keenan in the United States Navy in the Philippines; and his 16 uncle, James Carr, who served in the United States Marines in 17 Vietnam; and

18 WHEREAS, Mr. Keenan further wrote an essay about his 19 grandfather's World War II experiences, which was published as 20 part of Tom Brokaw's book, "Hometown Heroes"; and 21 WHEREAS, Mr. Keenan received multiple honors, including a personal letter of invitation from Admiral William J. Crowe, to 22 23 attend the National Youth Leadership Forum on Defense 24 Intelligence and Diplomacy in Washington, D.C.; and 25 WHEREAS, Mr. Keenan's interest and knowledge of history, as well as his intellect and his academic achievement in writing 26 and research into the Civil War and participation in 27 28 reenactments and in the Pennsylvania Gettysburg Monuments 29 Project and other activities at the battlefield, prompted 30 Representative Harry Readshaw to invite him to give a

1 presentation about the Civil War; and

2 WHEREAS, Mr. Keenan, who was 13 years of age at the time, 3 spoke fluently and eloquently about the subject with no notes 4 for five minutes, prompting the members of the House of 5 Representatives to rise to a standing ovation; and

6 WHEREAS, Mr. Keenan attended Johns Hopkins University 7 studying sociology and psychology and planned to work as a guide 8 for international mountain climbers; and

9 WHEREAS, For years, Mr. Keenan trained every day at Brown's 10 Gym in Clarks Summit and, as part of his training regimen, ran 11 between 10 to 12 miles daily; and

12 WHEREAS, The following family and loved ones survive Mr. 13 Keenan: his mother, Diane Lozinger-Keenan, with whom he resided; two sisters, Candis Nesgoda of White Haven and Diane Carson of 14 15 Scranton; brother, Jeffrey Lozinger of Clarks Summit; half-16 brothers, Jimmy, Tommy and Paul Keenan, all of New York; uncle, Edmund Carr, and his wife, Darlene, of Clarks Summit; aunt, 17 18 Charlotte Boyle of Minnesota; nieces; nephews; cousins; and many 19 friends and fellow climbers; and

20 WHEREAS, The following family members preceded Mr. Keenan in 21 death: his father, James Keenan and brother, John (Duke) 22 Lozinger; maternal grandparents, Clara and Edmund Carr; aunt, 23 Janet Howells; and uncle, James Carr; and 24 WHEREAS, Mr. VonRueden recently began a career as an 25 emergency medical technician and developed a passion for

26 traveling after finishing high school in Watertown, Wisconsin; 27 and

28 WHEREAS, Mr. VonRueden is survived by the following family 29 members: parents, Peter and Renee VonRueden, both of Clyman, 30 Wisconsin; and brother, Aaron VonRueden of Portage, Wisconsin;
