A RESOLUTION

Urging the United States Department of Transportation and the 1 National Transportation Safety Board to conduct a 2 comprehensive inspection of all railroads in this 3 Commonwealth to ensure that the railroads are capable of 5 withstanding the increased traffic that is occurring due to the transportation of crude oil. 6 7 WHEREAS, In recent months, the shipping of crude oil by rail from North Dakota to various locations throughout North America, 8 including this Commonwealth, has substantially increased; and 10 WHEREAS, Along with this increased rail traffic has come an 11 increase in accidents involving trains carrying the crude oil; 12 and 13 WHEREAS, During the past year, there have been accidents 14 involving trains carrying crude oil in this Commonwealth, 15 including a derailment in Philadelphia and an incident in the 16 Pittsburgh region that resulted in a spill, as well as a very 17 serious and violent derailment and explosion in Virginia; and 18 WHEREAS, At least one of the accidents was a result of 19 improper maintenance work; and

- 1 WHEREAS, Railroad companies have the duty to inspect their
- 2 own rails and usually do not have a third party verify the
- 3 results of their inspections; and
- 4 WHEREAS, The recent increase in accidents involving trains
- 5 carrying crude oil suggests that railroad companies are not
- 6 effectively executing their duty to inspect their own rails; and
- 7 WHEREAS, The Commonwealth will not stand by and wait for a
- 8 catastrophic event to occur in this Commonwealth before taking
- 9 action on this issue; and
- 10 WHEREAS, The Federal Government is responsible for overseeing
- 11 the railroads in this nation; therefore be it
- 12 RESOLVED, That the House of Representatives of the
- 13 Commonwealth of Pennsylvania urge the United States Department
- 14 of Transportation and the National Transportation Safety Board
- 15 to conduct a comprehensive inspection of all railroads in this
- 16 Commonwealth to ensure that the railroads are capable of
- 17 withstanding the increased traffic that is occurring due to the
- 18 transportation of crude oil; and be it further
- 19 RESOLVED, That copies of this resolution be transmitted to
- 20 the United States Department of Transportation and the National
- 21 Transportation Safety Board.
