AS AMENDED ON SECOND CONSIDERATION, HOUSE OF REPRESENTATIVES, JUNE 11, 2013

## AN ACT

- Amending the act of December 15, 1986 (P.L.1610, No.181), entitled "An act providing for the establishment and 2 operation of a Statewide system for the prevention and 3 control of rabies; imposing additional powers and duties on the Departments of Agriculture and Health; providing for emergency declarations; fixing penalties for violations; and 6 making an appropriation," further providing for findings, for legislative intent, for definitions, for Statewide system for rabies control, for powers and duties of department, for 8 9 testing, for vaccination required and certificate and tag, 10 for antirabies clinics, for veterinarians participating in low-cost rabies clinics and for powers and duties of 11 12 department relating to wildlife. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: Section 1. Sections 2 and 3 of the act of December 15, 1986 16 17 (P.L.1610, No.181), known as the Rabies Prevention and Control in Domestic Animals and Wildlife Act, are amended to read: 18 19 Section 2. Findings. 20 Incidence of rabies. -- [The incidence of rabies
- 21 throughout this Commonwealth has increased over the past six
- 22 years in alarming proportions. In 1985, 450 laboratory-confirmed
- rabies cases were reported in this Commonwealth, as compared to

- 1 only 16 confirmed cases in 1979. Furthermore, the epidemic is
- 2 spreading across the State. In 1981, only nine counties reported
- 3 cases of rabies, whereas, in 1985, rabies cases were reported in
- 4 almost half the counties of this Commonwealth.] Each year
- 5 <u>several hundred cases of rabies in animals are reported in this</u>
- 6 Commonwealth. The animals include wild animals, livestock and
- 7 domestic pets. Human exposure can occur through contact with
- 8 rabid animals.
- 9 (b) Impact of rabies epidemic. -- The socioeconomic impact of
- 10 [the epidemic is frightening. Not only is the postexposure
- 11 treatment costly, but the rabies in animals and humans is
- 12 significant. Infection by the rabies virus is almost always
- 13 <u>fatal. The</u> protocol surrounding a single suspected rabid animal
- 14 requires the expenditure of both monetary and human resources by
- 15 the department, and the human postexposure prophylaxis is
- 16 <u>expensive</u>.
- 17 Section 3. Legislative intent.
- 18 It is the intent of the General Assembly to provide a
- 19 comprehensive rabies control program involving [research]
- 20 control, prevention and education [which will protect the
- 21 citizens of this Commonwealth from an unnecessary and harmful
- 22 rabies epidemic].
- 23 Section 2. The definition of "rabies" in section 4 of the
- 24 act is amended and the section is amended by adding definitions
- 25 to read:
- 26 Section 4. Definitions.
- 27 The following words and phrases when used in this act shall
- 28 have the meanings given to them in this section unless the
- 29 context clearly indicates otherwise:

- 1 <u>"Certificate of vaccination."</u> A certificate verifying
- 2 vaccination against rabies, containing information consistent
- 3 with the current version of the National Association of State
- 4 <u>Public Health Veterinarians Rabies Compendium.</u>
- 5 \* \* \*
- 6 "Direct veterinary supervision." Occurs when a veterinarian
- 7 <u>is on the premises and has given either oral or written</u>
- 8 <u>instructions to a certified veterinary technician or</u>
- 9 <u>noncertified employee and is easily and quickly available to</u>
- 10 assist the certified veterinary technician or the noncertified
- 11 <u>employee</u>.
- 12 "Dog Law." The act of December 7, 1982 (P.L.784, No.225),
- 13 <u>known as the Dog Law.</u>
- 14 "PERMANENT IDENTIFICATION." AS DEFINED IN SECTION 102 OF THE <--
- 15 ACT OF DECEMBER 7, 1982 (P.L.784, NO.225), KNOWN AS THE DOG LAW.
- 16 "Rabies." [In man and animal, hydrophobia, an acute viral
- 17 disease of the central nervous system usually transmitted to man
- 18 through the injection of saliva by an animal bite.] A viral
- 19 <u>disease affecting the central nervous system of a mammal that is</u>
- 20 transmitted through contact with saliva or other potentially
- 21 infectious material such as neural tissue from an infected
- 22 animal, including, but not limited to, a bite, scratch and
- 23 contact of saliva or other infectious material with broken skin,
- 24 an eye or mucous membrane.
- 25 "Rabies vaccine." A product used to stimulate an immune
- 26 response to rabies, licensed by the United States Department of
- 27 Agriculture and listed in the current version of the National
- 28 Association of State Public Health Veterinarians Rabies
- 29 Compendium.

1	"Suspected of having rabies RABID ANIMAL." A mammal	<
2	exhibiting behavior that is suggestive of infection with rabies	
3	in the opinion of a veterinarian, public health official or	
4	official representative of the department, the Department of

6	"Vaccinated against rabies." The status of an animal that:	<

- 1 Section 3. Sections  $5_{7}$  6 and 7 AND 6 of the act are amended <--

- 3 Section 5. Statewide system for rabies control.
- 4 The department, in cooperation with the Pennsylvania Game
- 5 Commission and the Department of Health, shall establish a
- 6 Statewide system for the prevention and control of rabies in
- 7 both wild and domestic animals. The system will encompass [both
- 8 a comprehensive research program aimed at ending the rabies
- 9 epidemic in the wild and] a rabies control program which

- 20 Federal, State and local health or animal regulatory
- 21 authorities as necessary to perform its responsibilities
- 22 under this act. This includes the authority to enter into
- 23 agreements to facilitate the distribution of rabies vaccine-
- impregnated animal baits to wildlife within this Commonwealth
- 25 by Federal or local health or animal regulatory authorities,
- and to otherwise effectively allocate responsibilities,
- 27 <u>equipment</u>, expertise and manpower in furtherance of the
- 28 objectives of this act.
- 29 (3) Institute the relevant actions outlined in this act,
- 30 as well as others determined by the department until it is

- determined that the threat of the rabies epidemic no longer
- 2 exists.
- 3 (4) [Institute an intensive public education campaign on
- 4 rabies through newspapers, radio and television
- 5 announcements.] (Reserved).
- 6 Section 7. Testing.

- 7 All testing [and other necessary or appropriate rabies
- 8 control] conducted upon rabid or suspected rabid animals
- 9 appropriate to protect human life and safety shall be conducted
- 10 [free of charge] at State laboratories or other facilities—
- 11 designated by the secretary.

25	certificate shall provide the department written verification

21	or cat vaccinated. The description must SHALL include_<-
22	the breed, age, color, markings, sex and any
23	permanent identification markers such as a microchip
24	or tattoo.
25	(C) The <u>full</u> name, address, certification number
26	and telephone number of the person who administered
27	the vaccine.
28	(iv) Provide immediate access to the records
29	described in subparagraph (iii) upon the request of the
30	department.

- 1 (c) Certificate and tag of vaccination. -- Every licensed
- 2 veterinarian who vaccinates a dog or cat against rabies shall

<--

- 3 issue a [vaccination] certificate OF VACCINATION and tag
- 4 [provided by the manufacturer] to the owner. Information
- 5 contained in rabies vaccination records shall not be used for
- 6 the purpose of licensing animals or for taxation of individuals
- 7 for owning animals. For the purposes of this section, each
- 8 licensed veterinarian may select a vaccine of his choice and use
- 9 the procedures for administering it as are consistent with the
- 10 recommendations of the Federal agency which licenses the
- 11 vaccine.
- 12 (d) Enforcement.--[It shall be the duty of every] A police
- 13 officer or State dog warden or the designated municipal animal
- 14 control officer [to] shall issue a citation to every person who
- 15 owns a dog or cat which is not either:
- 16 (1) vaccinated <u>AGAINST RABIES</u> pursuant to subsection
- 17 (a),  $\frac{(a.1)}{(a.1)}$  or (b); or
- 18 (2) exempt from the vaccination requirement pursuant to
- 19 subsection (f).
- 20 (e) Animals received by nonprofit kennels. -- Notwithstanding
- 21 any provision of this act, a nonprofit kennel is not required to
- 22 vaccinate an animal received by the kennel for a period of ten
- 23 days.
- 24 (f) Exemption.--
- 25 (1) An exemption from vaccination against rabies for a
- dog or cat under subsection (a) may be granted if a licensed
- 27 <u>veterinarian examined EXAMINES the dog or cat and determines</u> <--
- that it would be medically contraindicated to vaccinate.
- 29 (2) An exemption statement must be completed and signed
- 30 by the veterinarian and dog or cat owner and must contain the

13	(D) color and markings;
14	(E) whether the dog or cat is intact, neutered
15	or spayed; and
16	(F) the current license number of the dog that
17	includes any tattoo or microchip PERMANENT <
18	identification, if applicable.
19	(vi) The signature of the owner of the dog or cat
20	and the address of the owner. If there is more than one
21	owner, and the owners are living at separate locations
22	where the dog or cat may be housed, the signature and
23	address of both owners is required.
24	(3) A rabies vaccination exemption AN EXEMPTION FROM <
25	VACCINATION AGAINST RABIES is valid for a period of up to one
26	calendar year, after which the dog or cat must SHALL be
27	reexamined. At the reexamination, the dog or cat must SHALL <
28	either be vaccinated against rabies or, if exemption status
29	still applies, a new certificate of exemption must SHALL be <
30	issued.

- 2 as part of the medical records and provide two copies to the

- 4 the signed exemption for their records and forward one copy

- 8 (G) THE OWNER OR OPERATOR OF A BOARDING KENNEL, AS DEFINED <--
- 9 <u>IN SECTION 102 OF THE ACT OF DECEMBER 7, 1982 (P.L.784, NO.225),</u>
- 10 KNOWN AS THE DOG LAW, SHALL REQUIRE THE OWNER OF EACH DOG FOR
- 11 WHICH THE BOARDING KENNEL IS TAKING CONTROL TO PROVIDE PROOF OF
- 12 AN UP-TO-DATE RABIES VACCINATION AT THE TIME THE DOG ENTERS THE
- 13 BOARDING KENNEL. THE PROOF OF VACCINATION SHALL BE KEPT ON FILE
- 14 AT THE BOARDING KENNEL FOR SEVEN DAYS FOLLOWING THE DOG'S
- 15 <u>DEPARTURE FROM THE BOARDING KENNEL. ALL RABIES VACCINATION</u>
- 16 RECORDS AND OWNER CONTACT INFORMATION FOR DOGS INVOLVED IN A DOG
- 17 ATTACK AT A BOARDING KENNEL SHALL BE MADE AVAILABLE TO THE
- 18 OWNERS OF ALL DOGS THAT ARE INJURED IN THE DOG ATTACK.
- 19 Section 5. Section 9 of the act is amended to read:

- 20 Section 9. [Antirabies clinics.
- 21 The department shall assist in the establishment of low cost
- 22 antirabies clinics. These clinics shall be offered at locations
- 23 and on dates as appropriate. The department shall establish
- 24 vaccination procedures for cats and dogs to be used at the
- 25 clinics. In assisting in the establishment of antirabies
- 26 clinics, the department shall cooperate with local veterinarians
- 27 and other local organizations.] (Reserved).
- Section 6. Section 9.1 of the act, added July 1, 1987
- 29 (P.L.184, No.23), is amended to read:
- 30 Section 9.1. †Veterinarians participating in low-cost rabies

- 1 clinics.
- 2 (a) General rule. -- Except as otherwise provided in this
- 3 section, no veterinarian or an assistant under [the direction of <--
- 4 the veterinarian] <u>DIRECT VETERINARY SUPERVISION</u> shall be liable <--
- 5 to any person for civil damages as a result of any acts or
- 6 omissions committed as a participant in a low-cost rabies clinic
- 7 established under section 9, unless the conduct of the
- 8 veterinarian falls below the standards generally practiced and
- 9 accepted in like circumstances by veterinarians performing the
- 10 same or similar acts, and unless it is shown that the
- 11 veterinarian did an act or omitted the doing of an act which the
- 12 veterinarian was under a recognized duty to another to do,
- 13 knowing or having reason to know that the act or omission
- 14 created a risk of actual harm to the person or property of
- 15 another. It shall be insufficient to impose liability to
- 16 establish only that the conduct of the veterinarian fell below
- 17 ordinary standards of care.
- 18 (b) Exception.--Nothing in this section shall be construed
- 19 as affecting or modifying any existing legal basis for
- 20 determining the liability, or any defense thereto, of a
- 21 veterinarian set forth in the act of December 27, 1974 (P.L.995,
- 22 No.326), known as the Veterinary Medicine Practice Act.

- Section 7 5. Section 10 of the act is amended to read: <--

- 25 Section 10. [Powers and duties of department relating to
- wildlife.
- 27 (a) Powers and duties. -- The department shall develop,
- 28 administer and enter into a contract with Wistar Institute for a
- 29 comprehensive multiyear wildlife vaccine research program, which
- 30 may include, but not be limited to, the following:

- 1 (1) The identification of an appropriate wildlife vaccine.
- 3 (2) The development of effective bait attractants for wildlife in the field.
- 5 (3) Assessment of the duration of the immunity of the 6 animal, once vaccinated, as well as the effects of the 7 vaccine on wildlife, its safety and stability, and the 8 economics of vaccine production.
- 9 (4) The identification and development of a distribution 10 system for the dissemination of the bait in rural and urban 11 environment.
- 12 (b) Monitoring and reporting of research activity.--
- 13 (1) Annually, the department in conjunction with the
  14 Wistar Institute shall provide to the General Assembly a
  15 status report of the research activity conducted from the
  16 prior year. The status report shall contain a summary of the
  17 research and the dollars expended.
- 18 (2) Prior to the distribution of the bait in rural and
  19 urban environments, a comprehensive report outlining the
  20 distribution procedure must be submitted to the General
  21 Assembly for review.
- 22 (c) Commission cooperation.--The Pennsylvania Game
- 23 Commission shall cooperate with the department in carrying out
- 24 the research activities required by this section.] (Reserved).
