AN ACT

- 1 Providing for State assistance grants to municipalities for 2 regionalizing police operations; imposing powers and duties
- on the Center for Local Government Services; and making an
- 4 appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Regional
- 9 Police Assistance Grant Program Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Center." The Center for Local Government Services within
- 15 the Department of Community and Economic Development of the
- 16 Commonwealth.
- 17 "Program." The Regional Police State Assistance Grant
- 18 Program established under section 3.

- 1 Section 3. Regional Police State Assistance Grant Program.
- 2 (a) Establishment. -- The Regional Police State Assistance
- 3 Grant Program is established and shall be administered by the
- 4 center.
- 5 (b) Purpose of grants. -- The center shall award grants to
- 6 municipalities that need financial assistance to regionalize
- 7 their police operations with other municipalities. Grant funds
- 8 may be used for staff salaries, police equipment and related
- 9 start-up expenses.
- 10 (c) State matching funds. -- The amount of each grant awarded
- 11 under this act shall be equal to the amount of Federal funds
- 12 received by the municipality from the Pennsylvania Commission on
- 13 Crime and Delinquency for the same purpose. No grant under this
- 14 act may exceed \$100,000 for any three-year period.
- 15 (d) Application. -- The center shall develop and distribute a
- 16 uniform application for applicants to submit for grants under
- 17 the program.
- 18 (e) Review. -- The center shall review applications submitted
- 19 for grants under the program and shall approve them if they are
- 20 complete and the applicant agrees to the terms and conditions
- 21 for the grant as determined by the center.
- 22 (f) Pro rata distribution. -- If there are insufficient State
- 23 funds appropriated for grants in any year, the center shall
- 24 distribute the grant funds on a pro rata basis.
- 25 Section 4. Rules and regulations.
- The center shall adopt rules and regulations necessary to
- 27 implement and administer the provisions of this act.
- 28 Section 5. Appropriation.
- 29 The sum of \$100,000 is appropriated to the Center for Local
- 30 Government Services within the Department of Community and

- 1 Economic Development for the purpose of making grants under this
- 2 act.
- 3 Section 6. Effective date.
- 4 This act shall take effect in 60 days.
