AN ACT

- 1 Authorizing senior citizens to claim an exemption from tax
- increases as to certain real property; and providing for
- 3 termination of the exemption.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Senior
- 8 Citizens' Property Tax Freeze Act.
- 9 Section 2. Exemption from property tax increases.
- 10 No political subdivision which imposes a real property tax on
- 11 residential property shall increase the tax or the tax rate on
- 12 the real property of an individual if all of the following
- 13 apply:
- 14 (1) The individual is 65 years of age or older.
- 15 (2) The individual currently resides on the property as
- 16 to which the exemption is claimed and has resided thereon for
- 17 at least five consecutive years immediately prior to claiming

- 1 the exemption.
- 2 (3) Neither the individual nor any other person with
- 3 whom the individual owns the property by joint tenancy,
- 4 tenancy in common or tenancy by the entireties is currently
- 5 claiming or otherwise receiving an exemption under this
- 6 section as to other property located in this Commonwealth.
- 7 (4) The individual's annual income, as defined in
- 8 Chapter 13 of the act of June 27, 2006 (1st Sp.Sess.,
- 9 P.L.1873, No.1), known as the Taxpayer Relief Act, is not
- 10 more than \$65,000.
- 11 Section 3. Application for exemption.
- 12 An individual may apply for the exemption allowed by section
- 13 2 by filing with the political subdivision which imposes the tax
- 14 a notarized statement containing all of the following:
- 15 (1) The applicant's name, residential address and Social
- 16 Security number.
- 17 (2) A certification that the individual is 65 years of
- age or older, currently resides on the property as to which
- 19 the exemption is claimed and has resided thereon for at least
- 20 five consecutive years immediately prior to claiming the
- 21 exemption.
- 22 (3) The names and Social Security numbers of all other
- owners of the property as to which the exemption is claimed.
- 24 (4) A certification that no taxes are in arrears as to
- 25 the property.
- 26 (5) Evidence that the individual's annual income does
- 27 not exceed \$65,000.
- 28 Section 4. Termination of exemption.
- 29 (a) General rule.--Except as provided in subsection (b), the
- 30 exemption allowed by section 2 shall be terminated, and the tax

- 1 and tax rate shall become current upon sale or transfer of the
- 2 property as to which the exemption is in effect, including a
- 3 transfer under a recorded real property sales contract.
- 4 (b) Exception. -- The exemption from property tax increase
- 5 shall not be terminated under subsection (a) if the sale or
- 6 transfer is to a joint owner, tenant in common or tenant by the
- 7 entireties who is 64 years of age or older at the time of the
- 8 sale or transfer and who is otherwise entitled to claim the
- 9 exemption.
- 10 Section 5. Reimbursement by Commonwealth.
- 11 The Department of Revenue shall reimburse political
- 12 subdivisions annually for the difference between the real
- 13 property taxes imposed upon individuals who are receiving
- 14 exemptions under this act and the tax liability which would have
- 15 been imposed if the exemptions had not been granted.
- 16 Section 6. Applicability.
- 17 This act shall apply to the tax year beginning January 1,
- 18 2014, and to all subsequent tax years.
- 19 Section 7. Repeal.
- 20 All acts and parts of acts are repealed insofar as they are
- 21 inconsistent with this act.
- 22 Section 8. Effective date.
- 23 This act shall take effect immediately.
