## AN ACT

- Amending the act of June 30, 1981 (P.L.128, No.43), entitled "An act authorizing the creation of agricultural areas," further 1
- 2 providing for limitation on certain governmental actions. 3
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 13(a) and (b) of the act of June 30, 1981
- (P.L.128, No.43), known as the Agricultural Area Security Law, 7
- amended May 15, 2006 (P.L.190, No.46), are amended to read: 8
- 9 Section 13. Limitation on certain governmental actions.
- 10 Approval required for condemnation and for certain other
- actions by an agency of the Commonwealth .-- No agency of the 11
- Commonwealth having or exercising powers of eminent domain shall 12
- 13 condemn for any purpose any land within any agricultural
- 14 security area which land is being used for productive
- 15 agricultural purposes (not including the growing of timber)
- unless prior approval has been obtained in accordance with the 16
- 17 criteria and procedures established in this section from the
- 18 Agricultural Lands Condemnation Approval Board as established in

- 1 section 306 of the act of April 9, 1929 (P.L.177, No.175), known
- 2 as "The Administrative Code of 1929." [The] Excepting a county
- 3 of the first class, a county of the second class or a county of
- 4 the third class, the condemnation approval specified by this
- 5 subsection shall not be required for an underground public
- 6 utility facility that does not permanently impact the tilling of
- 7 soil or for any facility of an electric cooperative corporation
- 8 or for any public utility facility the necessity for and the
- 9 propriety and environmental effects of which has been reviewed
- 10 and ratified or approved by the Pennsylvania Public Utility
- 11 Commission or the Federal Energy Regulatory Commission. In
- 12 addition, all State-funded development projects which might
- 13 affect land in established agricultural security areas shall be
- 14 reviewed by the appropriate local agricultural advisory
- 15 committee and by the Agricultural Lands Condemnation Approval
- 16 Board. Each reviewing body may suggest any modification to the
- 17 State-funded development projects which ensures the integrity of
- 18 the agricultural security areas against nonfarm encroachment.
- 19 (b) Approval required for condemnation by a political
- 20 subdivision, authority, public utility or other body.--No
- 21 political subdivision, authority, public utility or other body
- 22 having or exercising powers of eminent domain shall condemn any
- 23 land within any agricultural security area for any purpose,
- 24 unless prior approval has been obtained from Agricultural Lands
- 25 Condemnation Approval Board and from each of the following
- 26 bodies: the governing bodies of the local government units
- 27 encompassing the agricultural security area, the county
- 28 governing body, and the Agricultural Security Area Advisory
- 29 Committee. Review by the Agricultural Lands Condemnation
- 30 Approval Board and the other indicated bodies shall be in

- 1 accordance with the criteria and procedures established in this
- 2 section. [The] Excepting a county of the first class, a county
- 3 of the second class or a county of the third class, the
- 4 condemnation approvals specified by this subsection shall not be
- 5 required for an underground public utility facility that does
- 6 not permanently impact the tilling of soil or for any facility
- 7 of an electric cooperative corporation or for any public utility
- 8 facility the necessity for and the propriety and environmental
- 9 effects of which has been reviewed and ratified or approved by
- 10 the Pennsylvania Public Utility Commission or the Federal Energy
- 11 Regulatory Commission, regardless of whether the right to
- 12 establish and maintain such underground or other public utility
- 13 facility is obtained by condemnation, or by agreement with the
- 14 owner.

- 16 Section 2. This act shall take effect in 60 days.
